Contract, if awarded, will be on a lump sum basis. No bid may be withdrawn for a period of 60 days after time has been called on the date of opening.

#### **SECTION 1 - GENERAL INFORMATION**

#### 1.0 DEFINITIONS

- 1.2.1 The terms "Bidder" and "Contractor" refer to those parties who are submitting proposals for the work set forth in this document.
- 1.2.2 The terms "Owner", "District" and "ACSD" refer to Allendale County School District or its designated agent.
- 1.2.3 Where the words "shall" or "must" are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
- 1.2.4 Where the words "should", "may", or "is desirable" are used, it signifies desirable, but not mandatory functions or capacities. Proposers who are able to provide these functions or capacities may be evaluated more favorably than those who cannot.

Prior to contract signing, Proposers shall not contact Board of Education members or other District Staff project team members regarding these specifications for any reason. Failure to comply may result in immediate rejection of proposal.

#### 1.5 BID EVALUATION

1.5.1 Bids submitted may be reviewed and evaluated by any person at Owner's discretion, including non-allied and independent consultants retained by Owner now or in the future.

#### 1.6 BID WARRANTY

1.6.1 The Bidder shall represent and warrant that the requirements are fully understood in all matters affecting the performance of the services and furnishing the labor, supplies, material and equipment required of these services.

#### 1.7 ACCEPTANCE OR REJECTION OF Bids

- 1.7.1 The Owner reserves the right to reject any or all bids when such rejection is in the best interest of the Owner; to reject the bid of a Bidder who has previously failed to perform properly or complete on time contracts of a similar nature; and to reject the bid of a Bidder who, in the opinion of the Owner, is not in a position to perform adequately the contract.
- 1.7.2 The Owner reserves the right to reject any or all bids, , waive any technicalities, and award any portion of or the entire contract in a manner that is in the best interest of the Owner.

#### 1.8 TERMS & CONDITIONS

- 1.8.1 The exact terms and conditions for executing the work will be in accordance with the Terms and Conditions issued in this bid package. The contractor acknowledges by submittal of the proposal that these will become part of the contract for construction.
- 1.8.2 Sections of the bid package, including the specifications and the completed proposal document with required attachments, will become part of the contract documents. The Contractor should, therefore, exercise the utmost care in completion of their bid.
- 1.8.3 If the Bidder fails to object to any condition of the RFP, it shall mean that the Bidder agrees with and will comply with the conditions set forth herein.

#### 1.9 HOLD HARMLESS

1.9.1 In submitting a proposal, the Bidder understands that Owner will determine at its discretion which bid, if any, is accepted. The Bidder waives any right to claim damages of any nature whatsoever, based on the selection process and any communications associated with the selection, and the final selection of the successful Bidder.

#### 1.10 STANDARD OF PERFORMANCE

1.10.1 The contractor must begin and complete the performance of the work required under the contract with all due diligence and must exercise the highest degree of professional skill, confidentiality, and competence in the performance of the services described therein.

#### 1.11 CONFIDENTIALITY

Contractors shall be required to visibly mark as "Confidential" each part of their bid which they consider to be proprietary information that could be exempt under the Freedom of Information Act. The District reserves the right to determine whether this information should be exempt from disclosure.

### 3.0 BASIC PROJECT REQUIREMENTS

# 3.1 <u>Performance Requirements for Track and Field</u> Equipment:

Intent: It is the intent of this bid that the vendor(s) provide the specified track and Field Equipment, delivered to the track facility.

- 1. Vendors are required to submit their bids on the attached bid form.
- 2. Bids will be awarded by  $\underline{EACH}$  Equipment Package as listed on the bid form, not but total cost of all Packages.
- 3. Bids for each package MUST include all costs for that package including cost of equipment, shipping, taxes (if applicable), discounts or other costs.
- 4. Bidders are provided specifications as the basis for the products to be bid on for each package. It is the bidder's responsibility to provide products that are equal to or better than the specifications.

- 5. Bidders must provide the Product Documentation Form (provided at the end of the bid form) as part of their bid. This form allows the District to compare the product which the bidder is providing in their bid, to the Standard required in the bid documents.
- 6. The District will review the bid and the equipment specification provided by the Bidder for their specific equipment and determine if the equipment provided in their bid meets or exceeds the standards established in the bid documents for the equipment. Bids for Equipment deemed to NOT meet the established bid standards will be rejected.
