- d. Special Services Director: Brought the Board up to date with a current student number handout which included #s of students and #s of IEPs. Lynn also explained the 504 accommodations for students.
- e. Business Manager: The audit booklet was circulated and David Alward, from Davis, Gates & Alward will be at the January 8 meeting to give an overview and answer any questions.
- f. Nutrition Program: Gayle Glidden had sought grant fund for an oven replacement at SACS and that grant as been received in the amount of \$8088.
- g. Superintendent: Todd talked about the major projects going forward which include: Mission, Vision and a Strategic Plan for the RSU vs. "flying by the seat of our pants".

He suggested that the Education Committee should take on the development of these projects.

He recommends that there be a Grant Committee to include: Board members, principals, parents and students.

He informed the Board of the move by the State to possibly forward Child Development Services to schools; this would include 3 years old children who require services. Todd, Laura and Steve attended the Legislative Forum held recently at Caribou High School. This proved to be an informative evening for legislators and for superintendents and board members, as well.
