WAYNESBORO AREA SCHOOL DISTRICT Waynesboro, PA 17268

The Waynesboro Area Board of School Directors met in regular session on Tuesday, November 14, 2017, in the board room at 210 Clayton Avenue. The meeting was called to order at 7:02 p.m. by President Kulla.

PLEDGE OF ALLEGIANCE

President Kulla opened the meeting with the pledge to the flag.

APPROVAL OF MINUTES

On a Bachtell/McDonald motion and unanimous voice vote, the Board of School Directors approved the minutes of October 24, 2017.

PUBLIC COMMENT

Maribeth Daniels, Weatherstone Drive, Waynesboro attended the Faculty Recital and thought it was a wonderful program and should be advertised better.

Ashley Garner, Scott Road, Waynesboro mentioned the board should consider offering a tuition kindergarten program (parents pay tuition for a half day) for those who wish to have their child attend a full day program.

PRESENTATIONS

Dr. Sterner-Hine presented information on the Keystone and PSSA exam scores and the School Performance Profile (SPP) Scores. Following are the building level academic SPP scores for each district building.

- Fairview Elementary 64.5 Moderate evidence that the school did not meet the standard for PA Academic Growth.
- Hooverville Elementary 80.9 Moderate evidence that the school exceeded the standard for PA Academic Growth.
- Mowrey Elementary 62.6 Moderate evidence that the school did not meet the standard for PA Academic Growth.
- Summitview Elementary 75.9 Evidence that the school met the standard for PA Academic Growth.

- WAMS 51.8 Significant evidence that the school did not meet the standard for PA Academic Growth.
- WASHS 83.2 Moderate evidence that the school exceeded the standard for PA Academic Growth.

Dr. Sterner-Hine highlighted the following areas of celebration for the district.

- Highest % of proficient/advanced PSSA math for Franklin County in grades 3, 4, & 5 Summitview Elementary
- Highest % of proficient/advanced PSSA math in Franklin County in grade 6 Hooverville Elementary
- Highest % of proficient/advanced PSSA ELA in Franklin County in grade 5 Hooverville Elementary
- Highest % of proficient/advanced PSSA Math (Historically Underperforming) grade 7 WAMS
- Fairview and Mowrey met standard for academic growth in 5th grade math in all 5 PVAAS quintiles
- WAMS Algebra 1 Keystone Results 103/106 were advanced or proficient = 97%

WASHS Areas of Celebration:

- Highest SPP within WASD for second consecutive year
- Highest Algebra KSE proficiency rates (overall and historically underperforming) in Franklin County
- Highest Literature KSE proficiency rates (historically underperforming) in Franklin County
- SAT/ACT Readiness Benchmark has increased every year since the SPP began, currently at 79.10 out of 100; second highest in Franklin County, behind Greencastle-Antrim Senior High School
- PVAAS scores in all three areas have met or exceeded state standards for growth over the past three years
- Second highest (high school) SPP in Franklin County, behind Shippensburg Area Senior High School.

STUDENT REPORT

Marcus Cooley commented on the Faculty Recital, stating it was very good. He reported on Business Education (21 interns placed in the community), FBLA (25 students attended the State Leadership Conference), Student vs. Faculty Football game, Health (99 students certified in CPR), Drivers Ed., Art, Tribe Time (ALICE video), Drama Club, Social Studies (Social Science Speaker Series), and sports.
