2022-23 School Overview

Parkview Elementary School is one of eleven schools in the Hueneme Elementary School District. Classes are arranged on a schedule comprised of trimesters. Kindergarten students attend an extended day, leaving at 1:30 p.m. Approximately 550 students in grades transitional kindergarten through five were enrolled during the most recent year. Of these, approximately half of the total student body is classified as English learners or Reclassified Fluent English Proficient (please see data tables included in this SARC), and 77.3% qualified for the free or reduced lunch program. All of our students receive free lunch and breakfast. Parkview is in its fifth year of implementing a 50/50 Two Way Dual Language Immersion Program. Parkview strives to improve student performance in Language Arts, Math, and English Language Development using collaboration around student data, implementation of research-based practices, and the encouragement of parental involvement. Parkview employs an English Learner Support Teacher, one full-time counselor, one part-time counselor, and three Acceleration Teachers that provide academic and social-emotional support to students.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. Parkview Elementary strives to maintain a safe, healthful, nurturing, and orderly school campus. Both students and staff contribute to keeping the campus a safe and comfortable place to learn and work. Teachers and support staff use CHAMPS, Positive Behavior Intervention, and Restorative Justice Strategies as a way to maintain safe and effective learning environments. Children are taught the six pillars of character through the Character Counts Program, which serves to prevent bullying and foster good citizenship. Parkview teachers use the Second Step curriculum to support social-emotional learning.

Parkview's School Safety Plan was developed in conjunction with the district's Comprehensive Safe Schools Plan. Updates for the 2021-2022 plan were reviewed by staff on February 28, 2022.

Professional Development

Administrators, teachers and paraprofessionals participate in professional development focused on the California Common Core State Standards in order to improve their skills in teaching and assessment of student learning. The primary focus areas are instruction of grade-level content standards, intervention strategies for students who have not mastered standards, and assessment of student progress.
