## **2020 Application for Appointment to Board of Education Seat**

## *OK State Statute 26-13A-110 (D):*

If after the filing period is closed no candidate for an open position on a board of education of a school district has filed and therefore a vacancy is created, the vacancy shall be filled by appointment by the board. Persons appointed to fill such vacancies shall not be required to reside in the board or election district but shall be required to reside in the school district and to meet the other eligibility qualifications needed to be a candidate for the position as provided for in Section 13A-106 of this title and Sections 5-110, 5-110.1 and 5-113 of Title 70 of the Oklahoma Statutes. Persons appointed to fill vacancies as provided for in this subsection shall be eligible to serve only for the balance of the term.

- If appointee resides within the vacant McLoud School District ward seat (5), the balance of the term will expire in 2021 or they must run for election.
- If appointee resides within the boundaries of the McLoud School District but NOT within the boundaries of the vacant ward seat (5), the balance of the full term will be served (5 years) until the next election for that ward seat.
- Applications as well as applicant names will not be made public. Questions, considerations, discussions for the open board seat appointment will be made in executive session on April 13, 2020 and only the appointed individual's name will be on public record.
