# DRIVE-RIGHT School of Driving, Inc.

Two-Year Contract for Driver's Education Instruction 2018-2019 School Year 2019-2020 School Year

In exchange for the fees outlined below, DRIVE-RIGHT School of Driving, Inc. agrees to instruct students of Pecatonica High School in a driver education course. This course will consist of the following stipulations:

- 30 hours of classroom instruction
- 6 hours of behind the wheel instruction
- 6 hours of observation instruction

## **COST OF COURSE PER STUDENT:**

- \$420.00 for classroom and behind-the-wheel. This fee includes the \$55 discount for taking the classes at Pecatonica High School.
- \$210 of the total fee to be paid by the school district.
- \$210 of the total fee to be paid by the parent/student.

#### BEHIND THE WHEEL STIPULATIONS:

- All lessons will begin and end at Pecatonica High School.
- All lessons can be scheduled directly with the Drive-Right instructor. Scheduling can begin once the student has their permit.
- For any behind-the-wheel cancellations, please call the Drive-Right office at (815) 965-4638 or the Pecatonica High School office **24 hours in advance**.

#### **USE OF FACILITIES**

• Pecatonica High School will provide facilities to Drive-Right without charge, including classroom space, to permit Drive-Right to offer driver's education classes to Pecatonica High School students on Pecatonica High School's campus. Pecatonica High School shall be solely responsible for normal maintenance of the facilities, including the classroom space used by Drive-Right.

## **CLASSROOM REQUIREMENTS**

• Students will follow all Pecatonica High School Handbook Rules and Regulations—when attending Drive-Right classes.

- The class will meet every day for 6 weeks, Monday Friday. Excessive tardiness will not be allowed.
- We will not tolerate any disrupting of the class. If this happens, the student will be dismissed from class and the instructor will call the parent to inform them of the infraction. If the problem persists, the student will be terminated from class.
- Drive-Right will hand back written work for student review, when applicable.

#### **DRIVERS EDUCATION**

- Drive-Right agrees to offer and provide driver's education classes to Pecatonica High School students on Pecatonica High School's campus.
- Drive-Right shall be solely responsible for planning and presenting the driver's education requirements imposed by the State of Illinois.
- Drive-Right shall provide all necessary teachers and substitutes. All driver's education teachers or substitutes shall be considered employees of Drive-Right and not employees of Pecatonica High School.
- Drive-Right shall abide by all drivers education guidelines stipulated by the Illinois State Board of Education.

#### **TERMINTATION**

• This agreement may be terminated by either party, without cause, upon one semester's advanced written notice, which must be given prior to the beginning of the prior semester to be effective at the beginning of the following semester.

#### TIMES AND LOCATIONS

• Times and locations will be mutually agreed upon between both the school district principal and DRIVE-RIGHT School of Driving.
