<u>CALL TO ORDER:</u> Chr Smith called the regular school board meeting to order at 7:00 PM. <u>MEMBERS PRESENT:</u> Chr Brian Smith, vice-chair Jason McAreavey, Makenzi Miles, Jill Johnson and Tori Lindstrom-Sieverding.

OPEN FORUM: Bryon Hahn addressed the board.

<u>APPROVE THE AGENDA:</u> Action #02-20-01, motion by McAreavey, second by Miles to approve the agenda as presented. 5 votes yes, motion carried.

CONFLICT OF INTEREST (SDCL 3-23): No conflict noted.

<u>CONSENT AGENDA:</u> Action #02-20-02, motion by McAreavey, second by Johnson to approve the consent agenda as presented including additional bills: General Fund: Home Service Water Conditioning, softener salt \$203.55; Jill Johnson, reimbursement \$26.78; Popplers Music, instrument repair \$5.70. General Fund: \$236.03. SPED Fund: Vicky Carsrud, mileage reimbursement \$289.80. Total additional bills \$289.80. 5 votes yes, motion carried.

<u>WEIGHT ROOM DISCUSSION:</u> Charlotte Thompson addressed the board as a Montrose Booster representative. She asked on their behalf if the school would help with the cost of the upgrade needs for the weight room. They will present what was discussed to their members.

<u>SCHOOL CALENDAR:</u> The proposed FY2020-21 school calendar was presented and discussed.

<u>PLAYGROUND DISCUSSION:</u> The playground committee has been asked to come with 2-3 proposals regarding playground equipment.

<u>SECOND READING POLICY SECTION K:</u> Action #02-20-03, motion by Miles, second by McAreavey to approve Section K School/Community Relations of the policy manual. 5 votes yes, motion carried.

SHARE OUR STRENGTH FOOD SERVICE PROGRAM: Action #02-20-04, motion by Johnson, second by Lindstrom-Sieverding to approve a three (3) year commitment to the proposed buyers group with 4-8 other small schools that would include access to a dietitian and to participate in the grant from Share Our Strength Foundation. 5 votes yes, motion carried.

Action #02-20-08, moiton by Lindstrom-Sieverding, second by McAreavey to approve a budget supplement for Special Education Fund, account 22 2742 000 331, contracted bus service for \$13,000 from fund balance. 5 votes yes, motion carried. She will send a survey out to determine feasibility. Elementary staff is in the final stages of choosing math curriculum. C) AD: Nothing to report.
