D. Langan distributed the final FY06 revenue and expenditure budgets along with the tentative FY07 revenue and expenditure budgets for final approval in June. He commended Business Manager Stacey Frederickson for her efforts in the budget development.

Tim Everson, Falls High School Principal gave the following report:

- Current enrollment is 648
- Registration forms have been completed by students and have been input into the computer system. The master schedule will be constructed per these requests.
- The Lieutenant Governor visited several classrooms on Friday the 12th with a presentation in Mr. Sandberg's US History class.
- Professors from Bemidji State University presented at the May 8th teacher

- inservice. They addressed the topic of personal growth plans.
- Tuesday, May 30th is the last day for seniors with a breakfast at 8:30 a.m. sponsored by the Elk's Club followed by graduation practice.
- Commencement is Thursday, June 1 at 7:00 p.m. in the Falls High School Gymnasium. This is also the last day of attendance for students K-11.
- The photo and q-comp approval has been posted to the MDE website.

Josh Koenig, Activities Director gave the following report:

- Both boys and girls track have won the Section 8 Tru Team meets and will be participating in Stillwater on May 20th for the state Tru Team.
- Girls' softball is currently 17-0 with two regular season games remaining. They have won the IRC tournament this year.
- The Boys' baseball team is doing well for a young team with many games lost by only one run.
- Boys/Girls golf is also enjoying a positive season.
- The year started with successful fall sports and continued through the spring season.

Jerry Hilfer, Falls Elementary Principal gave the following report:

- Current enrollment is 473.
- First Lady Mary Pawlenty visited with the 5th grade students in the Falls Elementary Library on the 12th. Students then drew portraits of her which are displayed in the hallway.
- Feedback from teachers on the May 8th inservice was positive. Teachers seem to feel the tasks are manageable. A Learning Team Leaders' meeting is scheduled for Tuesday, May 16th to organize for next year.
- A list of spring activities was distributed outlining the many field trips scheduled for May.

Beth Anderson, West End Elementary Principal gave the following report:

- Enrollments at West End Elementary are 96 for 1st grade and 88 for second for a total of 184.
- Pre-school screening was held last Friday. Field trips are in full swing with the 1st grade going to VNP and attending the 5-6th grade band concert. An Arbor Day presentation was given in the classrooms, a safety presentation and Diane Adams from the Library will talk about the summer reading program. Second grade students will be visited by a park ranger and tye dye t-shirts. June 1st is a picnic and movie day for West End Students.
- Report cards will be sent home with students on June 1st.
- All special education teachers have completed the HOUSSE application for each core area of teaching they perform. The Federal Government has now required all elementary teachers to complete an application for highly qualified also. They are in the process of compiling their information.

Don Langan, Superintendent of Schools gave the following report:

- Futureworks is in the process of conducting a survey of the community which replicates the 2004 survey. Results should be compiled for the June meeting.
- An effort by the County Attorney has been made to develop a common truancy policy for the three districts within the county. Her efforts are applauded by the

- state needs to determine what compulsory attendance and compulsory schooling are as they reflect on truancy.
- The Governor's visit went well and board member attendance was appreciated. The q-comp check is on display in the Superintendent's office.
- Relay for Life was organized by Rachel Amdahl assisted by the 10th grade class. The event at 365 in attendance with 24 survivors walking. A total of \$37,470.00 was raised by the even which is a record thus far.
- M. Lassila, Community Education Advisory Committee gave the following report:
 - At the last advisory board meeting they were updated on the Community Education Director position with all indications being that Rachel Amdahl will hold the licensure by next fall.
 - Backpack Junction will undergo some changes as personnel costs need to be trimmed, the \$25 registration fee will be re-implemented, and the hourly rate will be increased from \$2.25 to \$2.50
 - They were also updated on program needs, weekend custodian time and scholarships.
