Brandee Brown, K-8 principal, stated the district welcomed 9 new students 2nd semester. Brooklynn Dougherty attended Busch Gardens/Sea World 4-H Zoo Apprentice Program as part of her leadership role with MO 4-H this summer. She will be give a presentation at the next board meeting.

In the absence of Jeff Carr, Curriculum / Transportation Director, Geoff Neill, Superintendent, presented his report to the board.

Penny Fadler, Special Education Director, stated her department load increased 2nd semester due to the number of transfer in students. They are prepping for Preschool screenings. The Preschool waiting list continues to grow. As families have moved from the district, new students have been able to join the program when vacancies become available.

Mr. Neill presented the board with a list of budget amendments that are necessary mainly due to the mandatory recoding required due to ESSA. The district received a CTE Ag grant in the amount of \$4,406 to offset the Ag teacher's salary. This was not included in the original budget.

Mr. Neill presented the Athletic Director's report: Homecoming is set for January 18 with the annual Sturgeon Tourney the following week. The high school gym floor has been refinished thanks in large part to a donation from the Friends of Sturgeon Basketball.

Mr. Neill stated the Facilities Committee met for the first time on January 9. Six of the nine members were in attendance. The group toured the K-8 building and plans to tour the high school during their February meeting.
