### II. Residency

To obtain enrollment in the Bryan County School District, students must reside in the county with their natural parent(s), or court-approved legal guardian(s). Students and their parent(s)/guardian(s) must remain residents of the county for the entire period of enrollment in the School District. For enrollment purposes, a resident is defined as an individual who is a full-time occupant of a dwelling located within the county and who, on any given school day, is likely to be at their stated address when not at work or school. A person who owns property in the county, but does not reside in the county, is not considered a resident for these purposes.

#### A. Verification of Joint Residency

The person with whom the student lives must attach proof of residency, dated within the last five (5) days and must show parent, guardian or legal name and street address. Signature of person with whom student resides is to be signed in front of a School Official or a Notary Public.

#### B. Proof of Residency

  - b. Current homeowner's insurance policy
  - c. Current vehicle registration
  - d. County Registrar of Voters card
  - e. Current paycheck stub
  - f. Most recent income tax return
  - g. Current warranty or quit claim deed

If you rent and live on the resident property in Bryan County, please attach:

1. Copy of the lease/rental agreement; and
2. A current utility bill in your name showing residence property address or, if such service is included as part of the rental agreement, you must provide satisfactory evidence that is so included; one of the following items listed below (must include address):
  - a. Current homeowner's insurance policy
  - b. Current vehicle registration
  - c. County Registrar of Voters card
  - d. Current paycheck stub
  - e. Most recent income tax return

If you are living at a property with the owner or renter of the property in Bryan County, please attach:

1. The Residence Affidavit signed by the primary resident of the home and subscribed and sworn before a district school employee OR Notary Public.
2. A current utility bill in your name showing residence property address or, if such service is included as part of the rental agreement, you must provide satisfactory evidence that is so included; one of the following items listed below (must include address):
  - a. Current homeowner's insurance policy
  - b. Current vehicle registration
  - c. County Registrar of Voters card
  - d. Current paycheck stub
  - e. Most recent income tax return

**NOTE: If legal custody of a child is split between two parents**, in addition to the documents listed above, you must also attach a certified copy of the most recent court order identifying each parent's respective award of physical custody. You are responsible to immediately inform the school of any changes to the court order.
