#### **Guidelines**

The following will be used as guidelines for the selection of the recipient of the Advantage scholarship:

- 1. The applicant must meet the Initial Eligibility Qualifications as approved by the Stigler Chamber of Commerce and Stigler News-Sentinel, Inc.
- 2. Employees of the Stigler Chamber of Commerce and Stigler News-Sentinel Inc. are disqualified from participating in the selection process if their child or family member applies for the scholarship.
- 3. The selection of the scholarship recipient will be based on the following standards:
  - A. ACT score from Part I
  - B. Grade point average from Part II
  - C. Quality of classes taken from Part II
  - D. Extracurricular activities from Part III
  - E. Work ethic from Part III
  - F. Scholarship request from Part IV
  - G. Overall character

#### ADVANTAGE SCHOLARSHIP PROGRAM

#### **General Information**

The Stigler Chamber of Commerce and Stigler News-Sentinel Inc. administer a scholarship program, which is made possible by an endowment donation from the Stigler News-Sentinel, Inc. From this donation, a one time scholarship each year is offered to a deserving Haskell County high school senior upon graduation from high school. The scholarship will be approximately \$500.00 to \$1,000.00 and must be used by the recipient for educational purposes. The Stigler Chamber of Commerce and Stigler News-Sentinel Inc. will select the recipient of the scholarship in the spring of each year. The Stigler Chamber of Commerce and Stigler News-Sentinel, Inc will provide instructions and forms to each high school in Haskell County.

#### **Selection Qualifications**

It is the intent of the Chamber of Commerce and Stigler News-Sentinel Inc. to award the yearly Advantage scholarship to an eligible applicant who displays personal motivation and initiative, good citizenship and integrity, and who is committed to continuing their education.

#### **Initial Eligibility Qualifications**

In order to apply for the Advantage Scholarship, each applicant must meet the following minimum qualifications:

- 1. Each applicant must be a high school senior graduating in the current year from a high school located within Haskell County, Quinton or Porum.
- 2. Each applicant's principal must submit the official forms provided by the Stigler Chamber of Commerce and Stigler News-Sentinel Inc. on or before March 5th of each year. Failure to properly complete the application may disqualify an applicant. The application should be mailed to Stigler News-Sentinel Inc., P.O. Box 549, Stigler, OK 74462. Attn: Advantage Scholarship
- 3. Each applicant must be planning to attend a fully accredited college or university or vocational/technical trade school approved by the Stigler Chamber of Commerce and Stigler News-Sentinel Inc.
