1 POLICY: Alcohol, Marijuana and Drug-Free Workplace¹

CODE: B03 (MANDATORY)²

3 <u>Policy³</u>

- 4 It is the policy of the Maple Run Unified School District to maintain a workplace free of alcohol,
- 5 marijuana and drugs. No employee, volunteer or work study student⁴ will unlawfully
- 6 manufacture, distribute, dispense, possess or use alcohol, marijuana, or any unauthorized drug
- 7 on or in the workplace. Nor shall any employee, volunteer or work study student be in the
- 8 workplace while under the influence of unauthorized or illegal drugs, alcohol or marijuana. If
- 9 there are reasonable grounds to believe that an employee, volunteer or work study student is
- 10 under the influence of unauthorized or illegal drugs or alcohol or marijuana while on or in the
- 11 workplace, the person will be immediately removed from the performance of his or her duties.

12 **Definitions**

- Drug means any narcotic drug, hallucinogenic drug, amphetamine, barbiturate, marijuana, inhalants, or any other controlled substance as defined by state or federal statute or regulation.⁵
- 15 **Workplace** means the site for the performance of work for the School District, including any school
- 16 building or any school premises and any school-owned vehicle or any other school-approved
- vehicle used to transport students to and from school or school activities. It also includes off-
- 18 school property during any school-sponsored or school-approved activity, event or function such
- as a field trip or athletic event, where students are under the jurisdiction of the School District.⁶
- 20 Employee means all persons directly or indirectly compensated by the School District for providing
- 21 services to the district and all employees of independent contractors who provide services to the
- 22 district.⁷
- 23 Volunteer means an individual not employed by the School District who works on an occasional
- or regular basis in the school setting to assist the staff. A volunteer works without monetary
- compensation or economic benefits provided by the School District.
- 26 Work Study Student/Intern means a student who receives compensation for work performed at
- the school as part of a college work experience program. For purposes of this policy, an intern,
- working without pay, will be considered as a work study student.
- Student Teacher is a student working toward a teaching credential who may be placed at a school
 as a student teacher. A criminal record check must be completed.

31 **Employee Responsibilities**

32 Employees must keep secured any authorized medications that need to be taken at the workplace.

33 As a condition of employment, each employee will notify the Superintendent in writing of his or her conviction of any criminal drug statute for a violation occurring on or in the workplace as 34 defined above. The employee must notify the Superintendent no later than five (5) days after such 35 conviction. Entry of a *nolo contendere* plea shall constitute a conviction for purposes of this policy, 36 as will any judicial finding of guilt or imposition of sentence. Within ten (10) days of notification 37 38 from an employee, or receipt of actual notice of an alcohol, marijuana or drug conviction, the Superintendent will notify any federal or state officers or agencies legally entitled to such 39 40 notification.⁸

An employee, volunteer or work study student who violates the terms of this policy may be required to satisfactorily complete an alcohol or drug abuse assistance or rehabilitation program approved by the Superintendent. In addition, an employee who violates the terms of this policy will be subject to disciplinary action, including but not limited to non-renewal, suspension or termination at the discretion of the Superintendent or, if required, the Board.⁹

¹ Alcohol is not considered a "controlled substance" under federal law. The Drug Free Workplace Act therefore does not require that alcohol be included in an employer's prohibition of drugs in the workplace. Vermont law does authorize employers to prohibit alcohol possession and/or use of alcohol in the workplace. The Vermont drug testing law defines "drug" broadly, and includes alcohol as a "drug." 21 V.S.A. §511(3).

²The Drug Free Workplace Act of 1988 applies to all individuals or organizations that receive federal grants and any individuals or organizations that are federal contractors whose contracts exceed \$100,000. The Act does not explicitly require a Drug Free Workplace policy, but it does require covered entities to "…establish a drug-free awareness program to inform employees about…the *grantee's policy of maintaining a drug free workplace…"*. 41 U.S.C. §702(1)(b)(ii). Alcohol is not considered a "controlled substance" under federal law. The Drug Free

Workplace Act therefore does not require that alcohol be included in an employer's prohibition of drugs in the workplace. Vermont law does authorize employers to prohibit alcohol possession and/or use of alcohol in the workplace. The Vermont drug testing law defines "drug" broadly, and includes alcohol as a "drug." 21 V.S.A. §511(3).

³ The Drug Free Workplace Act requires specific actions on the part of employers including publication of a statement notifying employees of the prohibition against illegal drugs in the workplace, the establishment of a drug-free awareness program with specific elements, the notification to employees that compliance with the prohibition against drugs is a requirement for employment and imposing specific sanctions on any employee who is convicted of violations occurring in the workplace. *See* 41 U.S.C. §701.

⁴ The inclusion of volunteers and work study students as "employees" for purposes of this policy is optional. *See endnote 7 below.*

⁵ The Drug Free Workplace Act uses the term "controlled substance" as synonymous with the term "drug." Controlled substances are listed in the federal law at 21 U.S.C. 812.
