Value

Scholarships are \$1,000 each and may be used for tuition, fees, and/or textbooks. Scholarships are awarded for a one year period and must be used in the given year period. One scholarship per person per year, applicant may apply every year and may receive a scholarship for a maximum of four years.

Eligibility

The purpose of the Consumers National Bank Homer Unkefer Agricultural Scholarships is to assist students pursuing a higher level of education which will help them prepare for a career in agriculture. Awards are based on applicants experience in agriculture, and applicants must meet all of the eligibility requirements.

Eligibility Requirements:

1. Must have a minimum overall grade point average of 3.0 on a 4.0 scale.
2. Must be a high school senior attending a school in or residing in Carroll, Columbiana, Jefferson, Stark, Summit or Wayne county, or a graduate from a high school in Carroll, Columbiana, Jefferson, Stark, Summit or Wayne county currently enrolled in a 2 or 4-year college level agriculture curriculum.
3. Must supply an application for the scholarship, an essay, and a recent transcript (must show cumulative GPA) from applicant's current school with a school official's signature in a separate sealed envelope.
4. Applicant must meet ALL eligibility requirements in order to apply for a Consumers National Bank Homer Unkefer Agricultural Scholarship.
