2020 APPLICATION PROCEDURE

Quota International of Canton Ohio is proud to award academic scholarships each year to deserving students graduating from Stark County, Ohio high schools. Scholarship recipients will receive the sum of \$1,000 (paid directly to the college or university) from Quota-Canton to be applied to the cost of attendance as determined by each accredited college or university in the continental United States.

To be eligible for a Quota-Canton scholarship, the student must meet the following criteria:

- Have a cumulative Grade Point Average (GPA) of at least 2.5
- Be actively enrolled in college and entering the field of speech-language pathology, audiology, or deaf education. Applicants can also be speech or hearing impaired majoring in any field.
- Be a legal resident of Stark County, Ohio

In order to qualify for a Quota-Canton scholarship, interested students must submit a **completed** application package postmarked no later than **April 3, 2020** (for enrollment in the fall semester of the same calendar year). The scholarship committee reviews all applications submitted and evaluates each applicant on the basis of merit and financial need. In selecting scholarship recipients, the committee focuses on the following factors: *an applicant's financial need, academic performance and teacher evaluations; character and personal goals; and extracurricular and community activities and awards.*

Each applicant must submit the following by the April 3rd deadline:

- 1) the completed original application, signed by the applicant and his or her parent(s) or legal guardian(s)
- 2) a copy of the financial aid award letter received from the college being attended in the fall
- 3) a copy of the applicant's official high school transcript, showing **ACT test scores**, placed in a signed, sealed envelope by the school. The envelope should be returned to the student to be included with the application.
- 4) two completed teacher evaluations, signed and placed in signed, sealed envelopes by the evaluators and forwarded to Quota-Canton with the completed application
- 5) completed personal statement essay questions as requested in the application

IMPORTANT NOTE: Due to the number of scholarship applications received, it is the applicant's responsibility to ensure that all forms, attachments, etc. are completed and provided in their entirety. Applications received without all required information or postmarked after April 3rd will not be considered.

Quota-Canton will hold all information that it receives with respect to scholarship applications in the strictest confidence and will only use such information for internal purposes, unless an applicant directs otherwise.
