Educational Grant To Be Awarded: Application Must Be Received By: April 17, 2020

Grants of \$500 per college semester (maximum 2 semesters per student per year for 4 years) will be awarded to selected students attending college beginning the Fall 2020 school year. The scholarship will be extended for a fifth year for accounting students who enroll in a 5-year program that qualifies them to sit for the CPA exam. These students will need to submit the program documentation to receive the additional payment for the fifth year.

Criteria for Application:

- 1. Applicant must be a High School Senior who will declare a major in Accounting/Business in an accredited four-year college or university.
- 2. Applicant must be a U.S. Citizen or Permanent Resident (Green Card Holder).

- 3. Submit two letters of recommendation. The letters must be from a Teacher, Coach, Employer or Clergy, Etc. Family members and friends cannot submit letters of recommendation.
- Provide High School Transcript reflecting a GPA in junior and senior year of 2.75 or better out of a 4.0 scale.
- 5. Provide College or University letter of acceptance.
- 6. Provide resume of extracurricular activities, work experience, honors and achievements.
- 7. You must submit an essay of at least 500 words in response to the following:

"Why do you feel that the accounting/business profession may be suitable for you? Explain past experiences, challenges, thoughts, and future goals that bring you to believe that you could succeed in accounting/business."

Or, you can submit your college essay.

- 8. Application and documents to be postmarked by Friday, April 17, 2020. Incomplete applications or applications postmarked after April 17, 2020 will not be considered.
- 9. All finalists will be required to come in for an interview during the week of May 4, 2020 at the applicable Citrin Cooperman office.

ADDITIONAL REQUIREMENTS FOR WINNING APPLICANTS:

- 1. The selected student is required to maintain a GPA of 2.75.
- 2. Beginning with the spring of 2021 and each semester thereafter the student must submit the College or University's official transcript.
- 3. The student must be enrolled in an accredited college or university as a full-time student carrying a minimum of 12 credits per semester.
- 4. Grant recipients will sign a disclosure agreement allowing Citrin Cooperman & Company, LLP to use their photograph and information (i.e. name, college attending, demographic information such as gender, age, etc.) for press releases to the local newspapers and to be published in the firm's marketing material.
- 5. Grants will be disbursed to the student annually in two payments: \$500 during the Fall Term and \$500 during the Spring Term.
