## KWRL TRANSPORTATION

### SCHOOL BUS REGISTRATION INFORMATION

Ridgefield School District belongs to the KWRL Transportation Cooperative. This cooperative serves the local school districts of Kalama, Woodland, Ridgefield and La Center. Ridgefield School District provides school bus transportation for students who live in the school district's boundaries. Parents are required to register students to ride the bus. Parents can register their student using their Skyward credentials or Google profile. Bus stop and route information will be provided after the student is enrolled at their school and registered with KWRL. Please allow 1 to 3 business days to process your registration request.

Bus schedules are available on the KWRL website. For more information regarding bus routes and information, please call 360-841-2023 or visit their website ([www.kwrl.org](http://www.kwrl.org)). In order to keep on schedule, buses cannot wait for students who are late. District transportation will only pick-up and drop-off students at their registered residence, or at in-district licensed daycare providers (if enrolled).

*Transportation cannot be furnished for meetings of youth groups.*

*Student drivers are required to have parking permits, if available, at the high school.*

Skyward Credentials are required to log into the KWRL portal. Google Sign-in will work, provided the Gmail is registered in Skyward. If you need to reset your Skyward password or you have forgotten your Skyward Password, please call Maggie Butler at the District Office, 360-619-1309.

All students **currently** registered in the KWRL Portal will **NOT** need to re-register.

#### **Registration will ONLY be required for:**

- ◆ Kindergarten Students
- ◆ Newly Enrolled Students
- ◆ New Ridership (those who have not registered)
- ◆ Changes to an existing registration (adding alternate address, moved, etc.)
