## Visiting Patrons & Delegations

A) Superintendent Report - Student Success Act & Graduation Rates

Mr. Johnson presented results of the staff survey regarding the Student Success Act. Information was also presented on the Student Investment Account data for Ninth Graders on Track and the Four and Five Year Cohort Graduation Rate.

A community meeting about Oregon's new Student Success Act will be held on February 13<sup>th</sup> at 6:00 PM in the school district boardroom.

The Student Investment Account/Student Success Act application for funds has to be completed by the Superintendent, presented to the school district board of directors for approval and then submitted to ODE by April 15, 2020 for their approval.

Josh DeAnda, HS Graduation Specialist (Migrant Program) and Ricardo Buenrostro, Director of the High School Equivalency Program (HEP) at TVCC presented information on plans to help students obtain their GED.

#### Discussion -

- Not all students benefit from traditional HS, doesn't meet their needs
- Grant Provide programs to community, 5 year program
- · Offer HEP class on high school campus
- Grant program meets federal requirements
- Students age 16 on up are eligible
- Targeted students not on track, some seniors and a couple juniors
- GED students on high school campus from 8:30-11:30 a.m.; arrive and leave before other HS students, shared restroom facilities
- Four week partnership, 4 days per week until the end of June with one instructor for two content areas and another instructor for the other two content areas
- Offer instruction/materials in English and Spanish
- GED preparation in Language Arts, Math, Social Studies, and Science
- Student success in approximately 4-8 weeks
- GED celebration separate from our graduation ceremony
- Opens door for students to enter higher education
- Provide support to continue beyond GED, CTE skills with certification, pursue higher education, resources for advanced employment and military options
- Accountability for minor discipline and attendance
- Students with major discipline will attend the program on TVCC campus
- Payment towards credits is an option for eligible students and stipends are available for travel, day care, etc.
- Students who are not migrant can access the program at TVCC campus

#### Concern -

- Don't want to perceive the GED process as an easier route for students
- Program start date? Determine location, dates, time, etc.

## Recommendation -

- Focus on group(s) who won't get a regular or modified diploma
- Work with TVCC to monitor students participating
- Improve graduation rates, 5 year completers
- Finalize logistics and hold Student/Parent Orientation to discuss what to offer the expectations, etc.
- SSA dollars offer to include other students

There will be an informational meeting on Thursday with parents.

B) Aaron Mills – Social Studies presentation

Aaron Mills, Travis Sapp, Brett Jackman proposed bringing back a Social Studies teacher.

\*Discussion --\*

- Currently one middle school Social Studies teacher for three grades
- Mr. Sapp transferred back to HS full time
- Add teacher for 6<sup>th</sup> grade, possibly some 7<sup>th</sup>
- Reduce class size MS/HS classes, 580 students approximately
- Deficiencies recognized by MS/HS PLC group
- Detrimental to reading/literacy
- Keep state test scores from declining
- Students learn to help each other, better serve their community, and become informed, educated voters
- Preparation for future courses in Geography, US History, Civics, and Economics, etc.
- Put emphasis on real life skills
- HS Social Studies is currently the only class not offered as dual credit, Mr. Mills is working on this through CWI and Eastern

#### Concern -

• Credit transfers to TVCC from CWI (Eastern preferred per A.M.)

#### Recommendation -

- Dual credit offering students graduate with their HS diploma and an Associates
- PLC group doing a good job looking at curriculum alignments
- Possible use of Student Success Act dollars

# Measure 98 - High School Success - Resolution to approve and expend funds received

Nyssa School District 26 received unanticipated specific purpose funds from Measure 98 High School Success Sub-Grant to assist in improving student progress toward graduation beginning with grade 9, increase graduation rates, and improve high school graduates' readiness for college and career within the Nyssa School District.

These dollars need to be spent in the current fiscal year.

These dollars need to be separated from the general fund for the purpose of maintaining separation of eligible Measure 98 expenses.
