**For a student to participate in Segment 2**, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a Level 1 License which has been held for not less than 3 continuous months.

### TERMS

1. The parent/guardian agrees to pay the amount of \$50 at time of registration, either by check, cash or money order. This fee is non-refundable. **Registration is not complete without payment.**
2. Should a check be returned by the bank, a \$25 check fee will be charged, and student's certificate will not be issued until payment in full is received in CASH, plus the \$25 fee.
3. Requirements to pass the course are as follows: Student must have NO ABSENCES. A minimum of 70% on the State Test (with 2 retakes allowed, if needed).
4. In the case of an absence due to emergency, your student's instructor or Oceana Driving School (231-742-0258) must be notified ASAP. At this time, the possibility of a make-up day will be arranged.
5. Oceana Driving School LLC reserves the right to deny service.

### REFUND POLICY

If for any reason you decide to withdraw from the course before its completion, a refund will be based on the following:

1. A full refund will be issued if you withdraw **before the first session.**
2. A partial refund will be issued based on the sessions attended.
