> The buildings have documented a total of 516 walkthroughs.

Support of the Comprehensive School Improvement Plan

- ❖ Goal 2.1 Each year, grade-level cohorts will increase the percentage of students reading at or above grade level until 100% is obtained.
 - > To support the goal, we have enrolled our ELA teachers, reading specialists, and our instructional coach in Language Essentials for Teachers of Reading and Spelling (LETRS) training. The coursework explains the how what, and why of literacy and teaches essential knowledge and skills needed for students to master literacy fundamentals. Participation is highly encouraged by DESE.
 - Teachers participating and completing the coursework will be given a \$500 stipend through DESE and grants will cover the cost of the resources used for the training.
 - The professional development will provide a common resource for instruction and remediation grades K-5.
 - The goal is to send 100% of Parkview and CIS reading and special education teachers to LETRS.
 - Mrs. Parkey, our instructional coach, will seek trainer certification allowing her to provide the coursework to new hires and support our teachers in the future.
- ❖ Goal 2.4 The District will have 90% of the students attend 90% of the time.
 - ➤ Buildings are working with families to eliminate barriers for students with chronic absenteeism.
 - Each building is offering incentives for good attendance and plans are in place for those with chronic attendance.
 - The district has reached out to the prosecuting attorneys of Clinton, Caldwell, Davies, and DeKalb Counties to see if they can assist.
 - The district is projected to lose at least 50% of the points offered on the 2024 APR to low student attendance if we can't shift the current trend.
 - The district will be using <u>Attendance Works</u>, a national initiative, that focuses on improving student attendance and provides districts with quality resources.
- **❖** Goal 1.2 Professional development surveys will be offered and data will be used to determine building and teacher needs.
 - The District Professional Development Committee met to initiate plans for the 2023-2024 school year. The committee focused on creating a survey that will be shared with the certified staff seeking their needs and interests. Once the survey results are gathered, we will start planning the professional development budget and calendar.
