Dear Parent/Guardian/Caregiver,

As you are aware, the Governor has mandated all Massachusetts schools closed until April 7th, 2020, in response to concerns given the unprecedented situation created by the spread of COVID-19 (Coronavirus). These are extraordinary times, and the information and guidance from local, state, and federal authorities have resulted in decisions and actions that need to adapt to the quickly changing environment.

At this time, the following district guidelines are in effect regarding Special Education.

## New Referrals/Initial Eligibility/ Re-Evaluation in Process:

Granby Public Schools, along with other schools in the commonwealth, will be working with the Department of Elementary and Secondary Education on how we are addressing timelines for all students in a referral cycle or amid re-evaluation during this school closure. Once I hear from the Department, I will let you know how this will impact the process going forward.

## **IEP Meetings/Timelines**

Granby Public Schools, along with other schools in the commonwealth, will be attempting to hold (annual/review) IEP meetings virtually through, for example, ZOOM, a meeting APP. #### **Home/Hospital Tutoring:**

Home and Hospital Tutoring occurs outside of the school buildings. For students currently on approved home or hospital tutoring, the assigned tutor will contact the family to ensure the appropriate continuity of educational opportunities.

For students in Out-of-District day programs, the Out-of-District schools notified the Granby Public Schools that they would be providing educational opportunities during this closing. Please reach out to your assigned schools for further information.
