Here is a list of what is going on agency wide:</p> <ul style="list-style-type: none"> <li>•Head Start / Early Head Start – Closed classes until 3-27-20 at which time the situation will be re-visited and revised as needed. Will be checking in with parents/guardians for needs, etc.</li> <li>•Housing Choice Voucher – In person appointments are being cancelled. Housing applications will be processed by mail and/or email. Housing inspections will be temporarily postponed for recertification’s. Participants requiring return postage will be sent a stamped addressed envelope.</li> <li>•Energy Assistance – Mail-in application packets continue to be available. Participants will be told to mail-in the packets, none should be brought to the offices.
