**During the 2020-2021 school year the Sharon City School District developed an initial Phased School Reopening Health and Safety Plan that implemented various protocols and procedures which enabled the district to return to in-person instruction. Sharon City School District returned to in-person instruction for 5 days per week for all of the 2021-2022 school year. The District has been stalwart in its efforts to implement proven prevention and mitigation procedures which were and are in line with guidance from the CDC concerning the reopening and operations of in-person school facilities, and will continue to do so through the 2022-2023 school year.**

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

**Students returned to in-person instruction for 2021-2022 and will continue for the start of the 2022-2023. The Sharon City School District has developed and established summer remediation programs to address student academic needs. The District has purchased SEL curriculum and professional development services and resources and has maintained the services of a crisis counselor to help support student and staff social, emotional, and mental health needs. Furthermore, the district continues to provide year-long breakfast and lunches, free of charge, to all students throughout the year and will continue this practice for 2022-2023.**

c. <u>Handwashing and respiratory etiquette</u> ;	<p>Regarding Handwashing and Respiratory etiquette for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania.</p> <p>Additionally, the District has developed hand-washing protocols and procedures that will be continued into the 2022-2023 school year. Handwashing will be emphasized and encouraged through all buildings and among all students and staff. Throughout the entrances at all buildings and in all high traffic hallways hand-sanitizers have been and will continue to be made available for students, staff, and visitors. Hand-sanitizers are also made available for students and staff at the entry/exit points of all classrooms and offices.</p>

<p>d. <u>Cleaning</u> and maintaining healthy facilities, including improving <u>ventilation</u>;</p>	<p>Concerning the cleaning and maintaining of healthy facilities for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania. For example, ensuring that all high touch surfaces are cleaned, sanitized, and disinfected multiple times per day.</p> <p>All maintenance and custodians have received training on implementing compliant cleaning/disinfecting on all high-touch surfaces such as door handles, light switches, and desks. Additionally, faculty, staff, and administration will be provided disinfectant supplies and training to be used in classroom/offices throughout the school day.</p> <p>Lastly, the Sharon City School District is currently engaged in alteration and improvement projects or facility studies with respect to HVAC within multiple buildings.</p>
<p>e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with the State and local health departments;</p>	<p>Concerning Contact Tracing in combination with isolation and quarantine for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania.</p>

	<p>The Sharon City School District having provided in-person instruction throughout the 2020-2021 and 2021-2022 school years established effective and efficient protocols, procedures, and designated responsible persons for contact tracing and isolation/quarantine monitoring per PA Commonwealth and CDC guidance.</p>
<p>f. <u>Diagnostic</u> and screening testing;</p>	<p>Concerning Diagnostic and Screening Testing for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania.</p> <p>All Sharon School District employees will be responsible for performing daily self-health checks prior to entering any of the school buildings. Any employee registering a temperature above 100.4 should not report to work.</p> <p>Additionally, all parents will asked to health check their children prior to sending them to school or utilizing school transportation. The District strongly encourages all parents to keep sick children at home.</p> <p>Any and all students, faculty, administration, or staff member who becomes symptomatic during the school hours should immediately leave the classroom and report to the nurse's office. The nurse will then fully assess the individual and as the situation warrants, contact the parent or responsible family member to arrange transportation to leave the Sharon school building.</p> <p>The student's, staff, or faculty member's desk area will then be sanitized prior to subsequent use.</p>

Efforts to provide <u>vaccinations to school communities</u>;</p>	<p>In an effort to provide vaccinations for the School Community for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania.</p> <p>The Sharon City School District provided the opportunity during the 2020-2021 school year for all faculty, staff, administration, and associated school employees to receive the vaccination for the COVID-19 virus. During the 2021-2022 school year, the District provided vaccine clinics for students. The District will continue to provide information on vaccination sites to the Sharon School Community when these opportunities become available.</p>

Appropriate accommodations for students with disabilities with respect to health and safety policies; and</p>	<p>To continue to ensure that appropriate accommodations for students with disabilities with respect to health and safety policies are met for the 2022-2023 school year, the Sharon City School District will strive to comply with all guidance, directives, and orders extended by the CDC, the Pennsylvania Department of Health, and the office of the Governor of the Commonwealth of Pennsylvania.</p> <p>The Sharon City School District will continue to establish and maintain communication all parents of students who are, or are thought to be, in need of unique safety protocols due to complex needs.</p> <p>Sharon City School District teams will work with parents and other members of a student's IEP or 504 Team, to create a plan that allows all students access to a Free and Appropriate Public Education.</p>


