Notice is hereby given that on the 18<sup>th</sup> day of March, 2020, the Board of Trustees of the Floydada Independent School District will hold an emergency meeting at 5 p.m., in the Board Room Conference Room, 226 W. California Street, Floydada, Texas 79235. **An emergency or urgent public necessity exists that requires immediate action of the Board of Trustees, specifically, action concerning school closures, expenditure of public funds and implementation of alternate instruction methods in response to an imminent threat to public safety in light of the COVID-19 outbreak, declared to be a world-wide pandemic by the World Health Organization and the subject of a Disaster Declaration by the Governor of the State of Texas.** The subjects to be discussed are listed on the agenda that is attached to and made a part of this Notice.

If, during the course of the meeting covered by this Notice, the Board of Trustees should determine that a closed or executive meeting or session of the Board of Trustees is required, then such closed or executive meeting or session as authorized by the Texas Open Meetings Act, Texas Government Code, Section 551.001 *et seq.*, will be held by the School Board at the date, hour, and place given in this Notice or as soon after the commencement of the meeting covered by this Notice as the School Board may conveniently meet in such closed or executive meeting or session concerning any and all purposes permitted by the Act including, but not limited to the following sections and purposes:

- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
