Thank you for your extraordinary support and understanding, as we work together to protect our community during the growing coronavirus/COVID-19 pandemic. To further safeguard Illinois from the spread of the virus, Governor JB Pritzker has declared mandatory school closures for all buildings, both public and private, serving pre-kindergarten through 12th grade students. This is in place currently until March 30. These are uncharted waters for all of us. Information is fluid with this situation and changes rapidly even within a given day. 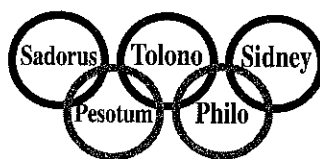
## Closure Details

- Unit 7 schools are closed for students beginning Monday, March 23- March 30. We anticipate that Governor Pritzker will allow us to reopen on March 31. Per the latest state guidance, the remaining days of closure will be considered Act of God days, which means that we will NOT have to make them up at the end of the year.
- Administration and limited staff will be in our building offices from 7:30 am- 2:00 pm during this closure to conduct business by phone or email.

## Meals

- Free bagged, grab-and-go breakfast/lunch sacks will be available for pick up daily beginning on Monday, March 23, from 9:30 AM to 10:30 AM at Unity High School, East side of the high school by the baseball field.
- These meals are for any Unit 7 students.
