AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters that we communicated to District management and Board of Directors in a letter dated March 11, 2020, related to compliance with procurement requirements. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Union Gap School District No. 2 from September 1, 2016 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Establishment of local revenue and expenditure accounts
- Use of restricted funds professional learning
- Self-insurance for unemployment
- Procurement public works, purchases, and professional services

- Electronic funds transfers for disbursements and payroll
- Associated Student Body activities fundraisers

The Union Gap School District serves approximately 600 students in Yakima County.

It is administered by a five-member Board of Directors. The District's 77 employees provide various services geared toward the educating of students in kindergarten through eighth grade. The District does not operate a high school. The District operated on annual revenues of approximately \$9,257,000, \$8,100,000 and \$10,270,965.73 for fiscal years 2019, 2018 and 2017, respectively.
