Central School District 51 plans to use the American Rescue Plan funds in the following manner to provide instruction for our students and to improve the environment in our schools.

- After school tutoring sessions- Students who need additional academic and social emotional support will be provided after school tutoring sessions based on universal screeners used multiple times throughout the year.
- Summer school for students- In order to provide support for our students who have been
 impacted by loss of instructional time, Central District 51 will provide summer school
 support for students as determined by staff. This summer school program will focus on
 evidence based strategies used throughout the school year.
- Summer enrichment activities- In order to further meet the academic needs of students, in addition to summer school, summer enrichment activities will be provided to students.
- Replace rooftop units- 4 rooftop units at Central Intermediate School will be replaced in order to ensure ventilation systems operate properly.
- Replacing Chromebooks for students- Chromebooks for kindergarten and 5th grade students will be replaced for the next two years in alignment with our district plan. This will ensure that students have access to devices that function properly.
- Mental Health services- Both Central Intermediate School and Central Primary School will have a full time school counselor to support students and staff social emotional needs.

As of 5.17.23 remaining funds will be used the following ways:

- 1. After school programs- Staff will continue to provide homework assistance for students.
- 2. Summer enrichment- The district will offer enrichment materials and programming for students.
- 3. An additional classroom teacher will be added for the 2023-24 school year to support students who were impacted directly by learning loss, in order to maintain a smaller class size for students at the primary level.
- 4. Replacement of two rooftop units for air quality at Central Intermediate School.
