Board Communications: Mr. Stegall stated that the State capital should have a budget in place by May 31st, but he stated that is highly unlikely. There is currently a bill being

presented requiring the inclusion of gay rights in high school curriculum. The bill has passed senate and will be going to the House. Another bill that has passed the senate is the bill that will require that districts can no longer provide alternate lunch for deficit balance accounts. Passed senate 41-9 going to house.

Mr. Stegall stated that he received an FOIA request from and employee of the Daily Journal regarding expenditures for the Triple I Conference.

Mrs. Kolitwenzue gave the board her report. The incoming freshmen placement tests have been completed. Mrs. Kolitwenzew shared those results with the board. She expressed her concern that only 31% of students at SAGS are ready for Algebra 1 and only 33 % of Pembroke students are ready for Algebra I. Additionally, of those kids that are currently

taking Algebra I at SAGS as 8th graders, only 29.4 % of those students scored 80% or better on the placement test.

Mrs. Kolitwenzew stated that she received the results of the Read Theory testing on 8th grade students at SAGS. The testing is an online reading comprehension test. Fourteen of those students are reading below a 4th grade reading level, 14 students are reading at 5th-6th-,7th grade level, with only 2-3 reading at grade level. Mrs. Kolitwenzew stated they will adjust classes and schedules accordingly. She is feeling confident that Mr. Nevills will do a great job moving students up to grade level. She has been seeing an average of 2 grade level increase in his classrooms. Next month she should be able to share SAT scores of the current juniors with the board.

Mrs. Kolitwenzew stated that the post prom festivities were "crazy good"! Sixty of the 90 students that attended prom also attended the post prom party.

Lily Cruz placed second ast KACC Skills USA, for criminal Scene Investigation. Taylor Deyoung placed 1st place in Creed at the section 10 Contest and Travis DeYoung placed 1st place for Job Interview at the section 10 contest and his 2nd place finish at the DIvision II Job Interview. Travis has qualified for State Contest in June.

Mr. Stegall stated that he did not have a need to go into executive session.
