Another new bill requires districts to hold an active shooter drill within the first 90 days of school.

Mr. Stegall stated that for the most part the Greenhouse has been completed. The district has been issued the occupancy permit from the ROE. He stated that he would like to schedule a ribbon cutting ceremony in the near future.

Mr. Stegall stated that the Teacher's return tomorrow for the first of two Teacher's Institutes and students will start on Monday, August 19th.
