Spotlight on Education-Nicole Bridges, 8th year social studies teacher presented the board with a road map for proposed changes in the social studies curriculum. With the proposed

Mr. Stegall stated that he was at an ROE meeting today. Dr Palan spoke on legislative activity being discussed. He stated that there is pretty strong talk about a shift of the teacher's pension cost to the school's in the work. Senate Bill 1970, has been passed both houses, which requires schools to allow an eligible student voters to have a 2 hour window during the school day to leave the building and vote.

Mr. Stegall and Mrs. Kolitwenzew presented the School Report card for FY 18/19. The report was released to the public on October 30th. School district's are given an over-all rating in one of the four categories. Those categories range from Exemplary, Commendable, Underperforming, and Lowest Performing. In 2018, SACHS was rated commendable on the 2018 school report card. Overall academic performance in 2018 for ELA was that 18% of our students met or exceeded the state average of 37% and in math our students were at 16% of our students met or exceeded the state average of 34%.

For the 2019 school report card, SACHS was rated commendable again. Overall academic performance in 2019 for ELA was that 25% of our students met or exceeded the state average of 37% and in math our students were at 14% of our students met or exceeded the state average of 35%. While they are happy to see the increase in the ELA the decrease in math in concerning. They spent some time talking about the overall picture of our students, demographics and mobility rate. If you don't know the whole story it might not look good, but when you do know the whole story it is not bad.

Mr. Stegall presented the levy for approval. There has been no change since the levy was presented last month. The levy is under the 5% aggregate increase. The total levy of \$2,352,728 includes the bonds and interest payment.
