REPORT OF THE SUPERINTENDENT:

Mr. Cox briefed the Board and members of the public on the district's response to the Covid-19 related statewide school closure, and what the district's plans going forward are. In brief:

- On March 13, 2020 Governor Jay Inslee ordered that all schools statewide be closed beginning March 17, 2020 through Friday April 24, 2020 in an effort to slow the spread of the virus, Covid-19.
- Prescott School District is scheduled right now to resume Monday, April 27, 2020.
- Enrichment packets with four weeks of content are being issued to students beginning March 23, 2020, these are made up of review materials, not core content. These will be developed by our teachers, who will be working from home during the closure.
- The district will distribute breakfast and lunch to students daily at 8:30 am and 9:30 am in Prescott and Vista Hermosa, respectively.
- The school building will be open every weekday of the closure except from April 3-12, the scheduled snow make-up day and spring break.
- Parents may request a phone conference by contacting the office to schedule something. Parents may also contact the office with any questions about instruction and they will be connected to their student's teacher.
- Classified employees will be working on a rotating schedule.


