Dear Okaw Valley CUSD #302 Students, Staff, and Families,

Governor Pritzker has extended the mandatory shutdown until Tuesday, April 7<sup>th</sup>, 2020. School is scheduled to resume on Wednesday, April 8<sup>th</sup>, 2020.

**Educational Instructional Packets:** Educational Instructional Packets will be available Monday, March 30<sup>th</sup> in all buildings at 10:00 am – 11:00 am, and 3:00 pm – 6:00 pm. The packets are not required, but the district encourages families to continue a learning experience during the mandated school shutdown. In the event these times do not work please email your building principal to schedule a time.

**Remote Learning Packet:** The district will have Remote Learning Packets to supplement the Educational Instructional Packet. To access the Remote Learning Packet go to [www.okawvalley.org](http://www.okawvalley.org) and click the icon labeled, *Remote Learning Packet*. The Remote Learning Packets will be modified periodically.

**Lunch Pick-Up Update:** The district will continue to provide daily breakfast/lunch “Grab and Go” every weekday for all students through April 7<sup>th</sup> from 10:00 am -10:30 am. In effort to make the situation more convenient, the district will offer families “Weekly Bundles” of food for a week at a time. Pick-up for all meals will be at OVES and OVMS only. The pick-up times for “Weekly Bundles” of food will be on Monday, March 30<sup>th</sup>, 2020 at 10:00 am – 11:00 am, and 3:00 pm – 6:00 pm.

**Facilities:** All facilities are closed until April 7<sup>th</sup>, 2020. This includes all school buildings, Okaw Valley Ag Complex, gymnasiums, weight room, and outdoor athletic facilities.


