- In order to do the naming of the track, we need a policy.
- Mr. Trusty stated there is a precedent for naming without a policy.
- A resolution will be placed on the March 19 agenda to name the track after Coach Reggie Williams.
- The Board agrees that the analyses presented by Mr. Kravitz and Ms. Balletto will be put on-line.
