SUPERINTENDENT'S REPORT

I would like to thank everyone for taking part in our zoom conference tonight.

What we have seen from all of the individuals in our school system over the last seven days is amazing. Teachers have been video conferencing with students, some of our principals have started reading to our students via instagram, teachers are communicating with students, and students are getting things done. Our security staff has worked each morning to assist in the distribution of food. Working with the recreation department we have expanded our food distribution to reach more children. Our buildings are getting scrubbed and sanitized daily.

As we move into our next phase of virtual instruction we will be developing mentoring programs in our high school for students who need extra assistance and continue to find innovative ways to offer instruction and make sure all of our children are prepared.

The situation is fluid with daily updates from the NJ Department of Education. Many of these updates are changes to our regulations, which are our laws. What may be normal for some are dramatic for us.

I thank everyone as we go through this difficult time and I remind everyone to check our website regularly and follow the CDC recommendations regarding ways to avoid the spread of the virus.

- Mr. Kravitz recognized that there is a deficiency with remote learning. It is not the same as sitting in front of a certified teacher.
- Please reach out to Bergen Family center regarding refunds for aftercare.
- Laptops A survey was sent to all the parents to find out who had technology, what kind of technology, and who had internet. The responses were quite low. We asked the children and received 3,200 responses. We then identified those students who needed devices and will contact them,. They will get them in the next few days.

Mr. Kravitz – There are programs where we need Dell computers. Dell computers are also needed for all our offices in the schools.

Mr. Kravitz – We cannot reopen by order of the Health Department.

Ms. Craig-Berry - All parks are closed.

Dr. Mullings – I would like to commend all teachers on on-line virtual learning. Moving forward, we should have age appropriate platforms.
