

Magazine School District Ready for Learning Plan 22-23 REVISED April 13, 2023

The goal of this plan is to provide students, staff, and parents of the Magazine School District with updated information throughout the school year as we continue to provide rigorous educational experiences while trying to navigate the challenges presented by the COVID-19 pandemic.

This plan is a fluid outline of the items that have been and will continue to be addressed and reviewed throughout the 2022-23 school year by our Continuity of Services Committee, which is made up of members from our Personnel Policy Committee (PPC), nurses, administrators, bus drivers, paraprofessionals, food service staff, maintenance staff, teachers, and parents.

The Magazine School District formulated this plan under the guidance and direction of the Arkansas Department of Health (ADH) and the Arkansas Department of Elementary and Secondary Education (DESE). As knowledge and resources have evolved throughout the pandemic, our district's policies and practices have consistently been updated to keep in line with current ADH/DESE directives and guidance.

Please understand that any/all information within this plan is subject to change based on new directives or guidelines that could be issued by the ADH and/or DESE. Updates to this plan may also be needed as new variants are introduced and/or positive case counts rise rapidly within our community or school district.

The Arkansas Department of Health and Arkansas Department of Education strongly advise districts to continue to follow all measures that have allowed successful in-person learning to occur.

 The success can be attributed to the multiple layers of mitigation strategies that have been implemented by schools, such as social distancing, reduced class sizes, mask-wearing, disinfecting and cleaning, handwashing, and physical distancing to the extent practical.

On Feb. 10, 2022 during a regular board meeting the board elected to discontinue masks wearing as a requirement. The Board will review this decision when the number of cases spike. At the time of this update no changes have been made to the Feb. 10th decision to discontinue wearing masks.

Considerations:

- Masks-Continuation of mask policies and proper wearing have benefits A school system may continue to require the use of masks for adults or students for whom it is developmentally appropriate.
 - Local school district boards must review current policy and determine whether to continue, modify, or eliminate by formal action policies that require the wearing of masks.
 - o If the district elects to continue a universal mask policy:
 - Proper mask wearing may be a consideration when identifying individuals as close contacts in K-12 schools that continue to implement mask requirements.
 - When making decisions districts should consider approaches that are safest for a variety of situations, such as, buses, classrooms, lunchrooms, hallways, activity and special event spaces to determine the extent and impact of changes.

Close Contact Identification

As knowledge and resources have evolved during the Pandemic, the response to COVID-19 has been modified to balance the educational and physical well-being in public schools. Contact tracing and quarantines for students who are identified as probable close contacts remain best practice as mitigation strategies, but there is no

directive for districts to do so. Isolation is still important for individuals who test positive for COVID-19 or for those who are symptomatic.

<u>Physical Distancing</u>: Provide a narrative of the local school board directive concerning physical distancing for the remainder of the school year. Add a link to any necessary policy or procedure or school board resolution.

The district will follow state guidelines concerning safety protocols and comply with Arkansas Department of Health directives.

The CDC has updated guidance to reflect the latest science on physical distance between students in classrooms.

The CDC still recommends social distancing of 3 feet between adults, as well as adults and students, in common areas, when masks can't be worn (such as while eating), during activities with increased inhalation like sports or band practice (which would preferably be held outside), and in community settings outside the classroom. At this time quarantines are no longer required by the school district. Physical distancing will be reinstituted upon a climb in cases.

Considerations:

Physical Distancing

CDC has updated guidance to reflect the latest science on the physical distance between students in classrooms.

 ADE now recommends but does not require that students can maintain a distance of at least 3 feet in classroom settings.

Responding

Schools are no longer responsible for responding to confirmed cases within the school district by identifying close contacts/quarantines. Governor Asa Hutchinson announced in a press conference that schools were to treat COVID as the flu.

Continuation of Services

As part of the American Rescue Plan Act, school districts must post for parents and the general public a summary of its plan for safe continuation of in-person learning and continuity of services.

Magazine School District will stay open as long and for as many days as possible.
 Closures will be dependent on the number of active cases. Closures may be specific classrooms, grade levels, buildings or the district.
