Many families do not know about, or take advantage of, these valuable tax benefits.

Save Receipts For Your Child’s Education Expenses

If you’re buying school supplies for your children in kindergarten through 12th grade, you may qualify for one or both of these tax relief programs:

- K–12 Education Subtraction
- K–12 Education Credit

Save your receipts, because both programs can help lower your taxes and may provide a larger refund when filing your Minnesota income tax return.

Last year, more than 17,500 families received the K-12 Education Credit and saved an average of \$282. Over 138,000 families received the K-12 Education Subtraction with an average subtraction of \$1,285.



Common Expenses That Qualify:

- School supplies (pencils, paper, calculators)
- Educational computer hardware and software
- Tutoring K-12 curriculum by a qualified instructor
- Rental or purchase of musical instruments used during school



Expenses That Do Not Qualify:

- School supplies not used in education (backpacks, tissues, organizers)
- Clothing, including school uniforms (except required gym clothes)
- School lunches
- Family trip to museum or zoo



Do I qualify?

To qualify for either the credit or subtraction, both of these must be true:

- You purchased educational services or materials to assist with your child’s education
- Your child is attending kindergarten through 12th grade at a public, private, or home school

Income limits for Each Program

K-12 Education Credit: Your adjusted gross income must be below the levels shown here. If you qualify for the credit, you must file a Minnesota return to claim a refund.

Number of qualifying children in K-12:	Adjusted gross income must be less than:
1 or 2	\$76,000
3	\$79,000
More than 3	\$79,000 plus \$3,000 for each additional child

K-12 Education Subtraction: There are no income limits for the education subtraction.

Guarde los recibos de los gastos de educación de su hijo

Si está comprando útiles escolares para sus hijos en los grados de K-12, puede calificar para uno o ambos de estos beneficios tributarios:

- Deducción para gastos educativos K-12
- Crédito de la educación K-12

Guarde sus recibos, ya que ambos beneficios pueden ayudar a reducir sus impuestos estatales y pueden aumentar el reembolso al presentar su declaración de impuestos de Minnesota.

El año pasado, más de 17,500 familias recibieron el crédito de la educación K-12 y ahorraron un promedio de \$282. Más de 138,000 familias recibieron la deducción de educación K-12 y ahorraron un promedio de \$1285.



Gastos comunes que califican:

- Útiles escolares (lápices, papel, calculadoras)
- Hardware y software educativo
- Tutoría de currículo de K-12 por un instructor calificado
- Alquiler o compra de instrumentos musicales utilizados durante la escuela



Gastos que no califican:

- Útiles escolares que no se utilizan en la educación (mochilas, pañuelos, organizadores)
- Ropa, incluido uniformes escolares (excepto la ropa de gimnasia requerida)
- Almuerzos escolares
- Viajes familiares



¿Califico para estos beneficios tributarios?

Para calificar para el crédito o la deducción, ambos deben ser verdaderos:

- Compró servicios o materiales educativos para ayudar con la educación de su hijo
- Su hijo debe estar matriculado en K-12 en una escuela pública, privada o de hogar

Límites de ingresos para cada programa

Crédito de educación K-12: Su ingreso bruto ajustado deben estar por debajo de los niveles que se muestran aquí. Si califica para el crédito, debe presentar una declaración de Minnesota para reclamar el reembolso.

Número de hijos calificados en K-12:	Ingreso bruto ajustado debe ser menos de:
1 o 2	\$76,000
3	\$79,000
Más de 3	\$79,000 más \$3000 por cada niño adicional

Deducción para gastos educativos K-12: No hay límites de ingresos para la deducción para gastos educativos.

Haddii aad u iibinayso qalabka iskuulka ee carruurtaada ku jirta kindergarten illaa fasalka 12aad, waxaad u qalmi kartaa nacfiyada canshuuraha midkood ama labadaba:

- K-12 Education Subtraction (Uga Goynta Waxbarashada K-12)
- K-12 Education Credit (Lacag ugu Celinta Waxbarashada K-12)

Kaydso rasiidhadaada, sababta oo ah nacfiyada labadooduba waxaa laga yaabaa in ay kaa caawiyaan yareynta canshuuraha lagaa rabo waxayna ku siin kartaa lacagta lagu soo celiyo oo korodha marka aad xarayso canshuur celintaada Minnesota.



Sanadkii la soo dhaafay, in ka badan 17,500 oo qoys ayaa helay Lacag ugu Celinta Waxbarashada K-12 waxaana u kaydsamay celcelis ahaan \$282. In ka badaan 138,000 qoys ayaa helay ka goynta Waxbarashada K-12 iyadoo celcelis ahaan ka goyntu ahayd \$1,285.

Miyaan u qalmaa?

- Si aad ugu qalanto u celinta ama ka goynta middood, labadaniba waa inay run noqdaan:
- Waxaad soo iibsatay adeegyo waxbarasho ama qalab si aad uga caawiso waxbarashada ilmahaaga
- Ilmahaagu wuxuu dhigtaa fasalka kindergarten ilaa fasalka 12aad ee iskuulada dadweynaha, kuwa gaarka loo leeyahay, ama iskuulka guriga

K-12 Education Subtraction: Ma jiraan xaddidaada dakhliga oo loogu talagalay uga goynta waxbarashada.

K-12 Education Credit: Dakhligaaga guud ee la hagaajiyay waa inuu ka hooseeyo heerarka halkan ka muuqda. Haddii aad u qalanto lacag ugu celinta, waa inaad xarayso canshuur celinta Minnesota si aad u dalbato lacag celinta.

- K-12 Education Credit

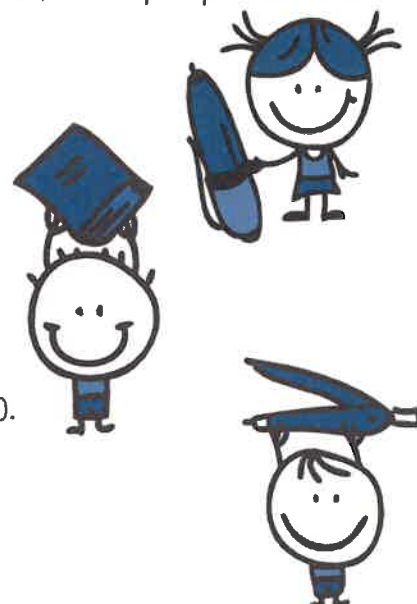


Khaws koj cov ntawv (Receipts) yuav khoom rau me nyuam kawm ntawv vim hais tias ob qhov kev pab no yuav pab koj cov se kom qis me ntsis thiab tej zawm nws yuav pab kom koj tau nyiaj se ntau dua.

Xyoo tas los, muaj ntau tshaj 17,500 tsev neeg tau txais qhov K-12 Education Credit los pab tau lawv tseg tau li \$282. Ntau dua li 138,000 tsev neeg tau txais qhov K-12 Education Subtraction ib cov tau li \$1,285 los pab qhov subtraction.

Cov Nuj Nqis Tsim Nyog Pab Tau:

- Cov khoom siv hauv tsev kawm ntawv (zoo li xaum, ntawv, lub lajj lej)
- Lub computer siv rau kev kawm ntawv, cov hardware thiab software.
- Cov nqis (pay/rent) nais khu pab qhia ntawv

- Cov khoom tsis yog siv rau kev kawm ntawv (ib yam li hnaab ev ntawv, ntaub so ntswg, organizer)
- Nqis siv internet
- Khaub ncaws nrog rau cov khaub ncaws yuav rau kev kawm ntawv (school uniform). Tsuas pub rau cov khaub ncaws yuav dhia ua si (gym clothes) xwb.
- Nqis yuav zaub mov.
- Cov nqis tsev neeg mus ua si

Kuv Puas Tsim Nyog Txais Kev Pab?

Kom koj tsim nyog txais tau kev pab, ob yam no yuav tsum muaj tseeb:

- Koj yuav khoom los pab koj tus me nyaum txoj kev kawm ntawv.
- Koj tus me nyaum kawm hoob kindergarten rau hoob 12 nyob rau hauv lub tsev kawm ntawv public, private los si kawm ntawv tom tsev.

Nyiaj Txaij Tsis Pub Tshaj (income limit) Rau Cov Program

K-12 Education Subtraction: Tsis muaj nyiaj txwv (income limit) rau qhov kev pab no.

K-12 Kev Kawm Credit: Cov nyiaj tau los tag nrho tsis pub tshaj li hauv qab no. Yog koj tsim nyog tau txais kev pab, koj yuav tsum tau file ib qhov Misnizsautas (Minnesota) return kom tau nyiaj rov qab (refund).
