**NOW THEREFORE BE IT RESOLVED**, the Board finds that Ms. Blake's untimely resignation would significantly impact the Board's ability to provide music education and, accordingly, the Board declines to gives its consent to Ms. Blake's resignation;

**BE IT FURTHER RESOLVED** that, should Ms. Blake abandon her duties under her contract with the Board notwithstanding the Board's decision, the Board directs its Superintendent to provide a copy of this resolution and other related information to the State of Ohio Board of Education and its designees for consideration of appropriate certification sanctions against Ms. Blake.

**BE IT FURTHER RESOLVED**, that it is hereby found and determined that all formal actions of the Board of Education concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Board, and that all deliberations of the Board and any of its committees that resulted in such formal action were open to the public when required by law, in full compliance with the law.
