 - A. <u>Advances on Tax Settlements:</u> authorization for the Treasurer to secure advances on local taxes from the County Auditor when funds are available and payable to the district.
 - B. <u>Investment of Active and Inactive Funds:</u> authorization for the Treasurer to invest inactive funds at the most productive interest rate whenever funds are available.
 - C. <u>Payment of Bills:</u> authorization for the Treasurer to pay all bills within the limits of the appropriations resolution as bills are received and when, if applicable, the merchandise has been received in good condition.
 - D. <u>Borrowing Authority:</u> authorization for the Treasurer and President to borrow funds, if needed, within the limitations established by state and federal law.
 - E. <u>Purchasing Agent:</u> authorization for the Superintendent to serve as purchasing agent for the district.
 - F. <u>Employment of Temporary Personnel:</u> authorization for the Superintendent to employ such personnel as are needed for emergency situations, as provided in the appropriations resolution and subject to being presented for Board approval at the next regular meeting.
 - G. <u>Approval of Leaves of Absence:</u> authorization for the Superintendent to approve unpaid employee leaves of absence as appropriate, consistent with the provision of the Negotiated Agreements.
 - H. <u>Approval of Board of Education's Designee for Appeals of Student Suspensions:</u> authorization for the Superintendent to appoint a designee for appeals of student suspensions.
 - I. <u>Approval of Out-of-State Trips:</u> authorization for the Superintendent to approve employee requests for out-of-state trips for professional development purposes.
 - J. <u>Adoption of Robert Rules of Order:</u> authorize the use of Robert Rules of Order at all board of education meetings.

K. <u>State and Federal Funds and Grants:</u> authorize the Superintendent to apply for available State and Federal Funds and Grants.
L. <u>Inter-Fund Transfers:</u> authorize the Treasurer to make inter-fund transfers as needed.
