PRESENTATIONS

 High School Robotics Team – Mr. Alan Gabriel, Teacher – Physics Class: Luke Chaffin, Nick Elster, Kelly Horch, Colby Reece, Garith Smith, Buddy Smith, Daniel Spencer and Jacob Wilson; Chemistry II Class: Lindsay Henson, Anthony Koch, Alyssa Lamb, Arie Leffel and Philip Obert

Mr. Brady introduced Mr. Gabriel, Physics and Chemistry II teacher. Mr. Gabriel – Students, Lindsay Henson and Alyssa Lamb will give a presentation about the Robotics Team Competition, LegoTron; Must use the Lego NXT Mindstorm Kit (may use additional Legos); Teams can only be high school students 18 years of age or younger; There can be two teams per school in the competition; A car must be able to travel the course totally through the programming of the car's "brain;" Students made their own course, but will be required to use the course set up for them at the competition; They will have 60 minutes to program the car's "brain" to navigate the course for the competition; The competition also includes a 30 minute presentation; The classes have been working on the project for about six weeks; The competition will be April 16th in Dayton, OH; The Physics and Chemistry II students held a demonstration and all were invited to observe.

Ms. Earich – This is an outstanding project in academics. Congratulations and I hope the competition goes well.

Mr. Gabriel – There will be many large schools in this competition and come from all across the country for the national competition; I would like to also talk about another program, our partnering with Southern State Community College; Last year we had 23 students earn eight hours of college credit; This year we have 21 in the program; This partnership with them has gone very well and I hope it will continue. *Mr. Dennis – Mr. Gabriel was sent via DuPont to San Francisco for the National Science Teachers Conference; Expenses were paid for by DuPont; We are very glad Mr. Gabriel was able to attend*

Mr. Gabriel – There were in excess of 20,000 teachers at the National Science Teachers Conference and over 2000 exhibitors; Our high school would fit in the exhibition hall; Robotics computer software was the main topics; We had breakout sessions at different places in San Francisco; Different ideas in science education were presented; Basis is to to try to get students interested in math and science

Mr. Brady – This was through a grant from DuPont and with the assistance from County Commissioner, Ms. Ula Jean Metzler, who helped get us a seat; Teays Valley Local Schools also sent a teacher to this conference.

Mr. Allen Koker introduced Coach Shane Wellman; This is his first year as head coach; His team won 5th out of 18 at the Sectional Tournament with only seven wrestlers competing and was 18th out of 58 at the Districts with only six competing; Coach Wellman had one wrestler, John Vulgamore qualify for the State competition and another wrestler, Derek Thomas qualifying as a State Alternate; John has a record of 41-8, was Sectional Champion, pinning his opponent who had a record of 52-0 and then was the District Runner-up, which qualified him for the State competition; Derek Thomas was 34-9 for the season, a Sectional Champion and finished 5th in the District qualifying him as an alternate for the State competition;

Mr. Brady – Thanks, Mr. Wellman for an excellent job this year.

4. Middle School Math Counts State Contest Qualifiers – Ms. Cindi Post, Teacher – Andrew Pettenski, Amanda Curry, Cody Walnoha, Zack Lemon and Kaitlynn Sandstrom

Ms. Kathy Payne introduced the State Qualifying Team of Middle School Math Counts participants; We are sending Mr. Gabriel some outstanding students; Mrs. Post, Math teacher is their advisor; This is a nationwide competition of 6th, 7th and 8th graders; We have competed for about 20 years; There are three parts to the competition, timed, individual and team competition; They finished 1st in the Southern Ohio Chapter Contest held in Circleville; The State competition was held at Columbus State, but results are not in at this time.

Ms. Velvet O'Day – Many of you are aware that some of our people have lost loved ones; A student in my class wrote a letter to one of these staff members; When I read this, it brought tears to my eyes; This is an example of what six year olds can write and how they feel. Mr. Caudill – I would like to comment on the caliber of students and staff we have here at Westfall. What they do here at school and in life is to be commended.

DISCUSSION ITEMS

1. High School Locker Quotes – Mr. Billy Dennis, Assistant Principal

Mr. Dennis – Many lockers at the high school do not work therefore, students don't use them; Carry backpacks; Price comparisons are finished and I have several quotes; Replacement would be around \$50,000; Looked at buying used lockers, did purchase a few this year; The lockers we have are in rough shape, coming out of the wall in some places; One company will fix and paint to working conditions; We have 540 original lockers; The custodians spend a lot of time working on them; If we replace them over a seven year period, it would cost about \$6,000 per year which does not include paint; Installation of new lockers would take time

Mr. Caudill – Has design changed?

Mr. Dennis – *MS lockers were replaced and they are still pretty much the same; Would like to go like MS*, *double stacked lockers*

Mr. Carfrey –I think we should have proposals and pricing for same type we would select; These quotes seem to be so far apart; Not so sure we are clear on what we are asking for; I know that the lockers are not being used but we need to obtain quotes that would allow replacement over a two to three year period, totally taking out lockers and using the two bank lockers to finish in three years Mr. Dennis – Wider lockers used more because more feasible; The company with

the higher quote didn't really want to do it

Mr. Carfrey – Electrostatic is a different process; Compare apples to apples *Mr.* Dennis – This is just a start for you to look over; Mr. Lehman has more to complete

Mr. Carfrey – This would come from permanent improvement fund

Mr. Caudill – Do the prices all reflect refurbishing

Mr. Dennis –All were very similar to what they were talking about

Mr. Carfrey – If we are going to paint them, it would be more cost effective to replace over time than to just paint

Mr. Dennis – The students like the few lockers that have been replaced

Mr. Carfrey – Are they combination style or padlock style

Mr. Dennis – The ones we have replaced are padlock style

Mr. Brady – If we were to go with the wider lockers, we would be losing lockers; If we went with the double stack that wouldn't happen, the number would actually increase; The used bank of lockers were installed and those that were removed have been used for parts

Mr. *Ruff* – *Is the quote from RS for the double tier?*

Mr. Dennis – Yes

Mr. Ruff – *What is the condition?*

Mr. Dennis – Used, but fairly good shape

Mr. Caudill – We will look this over and get back to you; We appreciate your work on this.

HEALTH COURSE-SUMMER SCHOOL

Mr. Brady – There is the Jefferson County ESC and some other options, but with this course it is self supporting with the fee we charge the students; This is a good way for students that have a full schedule and that are involved in extra-curriculars to get in the health credit; The elementary and middle summer school is paid through Title 1 Mr. Carfrey – How did we determine the different rates; What determines \$22.00 for tutors during the school year and then \$28.00 for summer school Mr. Brady – I don't have the answer for that; It was my understanding this was a

previously established rate

Mr. Carfrey – We are probably following the trend but I don't understand the difference Mr. Brady – I will research the minutes if you would like me to or you can table the motion

Mr. Carfrey – Yes, just check, no need to table.

PICKAWAY COUNTY ESC – RELATED SERVICES CONTRACT

(11-089) Motion was made by Ms. Reiterman, seconded by Ms. Earich to approve the related services contract with the Pickaway County Educational Service Center for the fiscal year 2012 in the annual amount of \$326,751.00 beginning July 1, 2011.

Mr. Ruff – Are we getting \$327,000 worth of work

Mr. Brady – Yes; Please look at the back page, use the school psychologist as an example; ESC came up with this formula many years ago of sharing services; ESC has 0 increase on the base salary, still have step increases, in some cases the number of days worked have been reduced; ESC has taken over the Brooks Yates Pre-school in 2010-2011 making a difference of about \$20,000 from last year to this year; So we are not being billed from Brooks Yates, but within the ESC package; We are fortunate that we get quality people in all of the positions; If we tried to hire all of these the cost would be greater

Mr. Carfrey - I'm confused by this; This is one of the largest expenses out of our budget; *I*'m not trying pick anyone out

Mr. Brady – For instance, the speech pathologist is 1.4 units which means we are getting a person and a half; Essentially if each district in the county were supported by one speech/language pathologist all four salaries are totaled and then divided by four; That is the formula used by the ESC

Mr. Carfrey – Are we able to ala-carte any of these positions

Mr. Brady – Yes, however there could be times we would not be able to get qualified people, if we were to have to contract out, we would have to pay mileage and other expenses

Mr. Carfrey – I'm just concerned about how many people use this service; It is a lot of money

Mr. Hiles – Are you asking how many are being served

Mr. Brady – There are a myriad of students being served; Most are a result of the IEP process, multifactor evaluation screening, speech/language services and OP/PT services that could be required

Ms. Earich – We can share; We have to address the needs of the students

Mr. Carfrey – I understand; Is this based on number of students

Mr. Brady – All of the county superintendents have been meeting on how to potentially share more staff in the future or as people move or retire; As Ms. Earich asked about

what kind of service can we share; We are currently contracting with the ESC of Central Ohio for our gifted coordinator; This is something we could share; But, have someone in house, on site and that is capable of taking over these duties; I am in the process of working out some of the small details which could save the district significant dollars.

Mr. Carfrey – In your professional opinion are we getting the services we need for the money

Mr. Brady – Yes

Ms. Reiterman – *Is this billed over the entire year*

Mr. Brady - Yes

Mr. Ruff – *Would you explain the pre-school to me*

Mr. Brady – The increase is due to the Brooks Yates teachers and aides being added to the ESC instead of the Brooks Yates Schools; In the past we have paid this cost to Brooks Yates; Now the Brooks Yates staff works for the ESC

Mr. Hiles – Insurance increase because of new staff

Mr. Caudill – Are these services we are required to provide

Mr. Brady – *Yes; Services have to be provided if required for the student, especially if written in their IEP*

Mr. Earich – The process starts very early and follows them all the way through, it is amazing how much we need

Mr. Brady – *Many are unfunded mandates*

TECHNOLOGY PURCHASE

(11-092) Motion was made by Mr. Caudill, seconded by Ms. Earich to approve the purchase of technology equipment for the special education department from Apple, Inc. as presented at a cost of \$18,510.00. This quote is below state term pricing and will be paid through ARRA Federal Funds.

Mr. Brady – I have checked on warranty of AppleCare; Since it didn't indicate the length of time; Two year period is misleading; Bumper to bumper type of warranty; Comes with a two year phone support; Longest amount of time given for warranty; If one would fall, break, etc. would be reimbursed

Mr. Carfrey –Looked on web site and it looked like it was a 12 month warranty; Do we get different warranties because of being a school; I am very concerned about this; I know it is stimulus money, but want to be sure of what we are purchasing and the need; I know this is needed for special education; I would like to verify the warranty and purchase the bumper to bumper warranty

Mr. Brady – My past experience with the Apple Care was a good one; The difference between a one and two year is that the one year is the factory warranty and 90 days of phone/tech support; The purchase of Apple Care adds another year, which also includes coverage if damaged and a full two years of phone and tech support; I would like to have Mr. Dennis explain the use of the equipment

Mr. Carfrey – I want to get the best we can

Mr. Brady – *Year one is for the product hardware; Year two is for unlimited protection and phone assistance*

Mr. Carfrey – *Can we purchase three years*

Mr. Brady – *No, two was the longest they would go on the Ipads*

Ms. Earich – Will this become obsolete

Mr. Dennis – The hardward is made to update; I have one that I updated;

Communication devices needed; Ipad can be purchased much cheaper than the Dynavox; Can use for speech; Story apps, can add pictures; Ibooks can be downloaded;
