PRESENTATIONS

- Promethean Board Ms. Velvet O'Day's 1st Grade Class Students, Ashton Nunemaker and Grace Wolfe; Mr. J. D. Williamson, Technology Director
 - Ms. Velvet O'Day introduced two of her first grade students; Ashton Nunemaker and Grace Wolfe; Each person in attendance were given a voting device (Promethean active expression) to use throughout the presentation; Ashton and Grace gave instructions on how to work the device and the audience participated in answering the questions displayed on the Promethean Board: The students use this as a learning tool in class for Math and other subjects; Ms. O'Day told how she uses the Promethean Board to teach in the classroom; Ashton and Grace showed us how they would use it as students; Ashton told us about how they use the Board for reading Scholastic News; The students can print what they have done on the Promethean Board and take the exercise home; Grace and Ashton demonstrated how to use the board to do various other assignments, create patterns, etc.; Ms. O'Day showed a video of the class, taken with a flip-cam and then loaded to the Promethean Board thanking the Board for the new technology; Ms. O'Day also thanked the parents for bringing their children to the meeting.
 - Mr. J.D. Williamson and the Westfall Technology Department "If we teach today the way we were taught yesterday we aren't preparing students for today or tomorrow." Unknown; Technology initiatives are: district web site, we are now up to 15,853 hits per week compared to 6,962 two years ago; Mobile Carts have been added to the middle and high school to benefit classroom instruction; BrainPOP site, both Junior and Senior, can be used here and at home; Progressbook, parents and

students can log on as well as teachers; Student Projects, Veteran's Day presentations done by the students; Middle School students made a video about what the day means to them, edited and put on a DVD to give to the veterans that day, the video was made with a flip-cam; Tech Tuesdays at the middle school, very successful and would like to do this at the high school and elementary school; Is helping the middle school to be confident with the technology; SIVDL Grant \$50,000 for the high school to put in a high tech lab to take college prep labs grades 9 through 12, held in the distance learning lab at the high school, money will last through next year; Blackboard-portal for the staff to have their class on line, not limited to the 40 minute window for class time; Middle school teacher, Ms. Rae Joseph will post assignments, announcements, units for her class for students to do in their free time, either at home or in study hall, by 2014 over 80% of classes will be on line in high school or colleges; goal to have all of their classes on line to be able to work on at home on a computer or iPad; Westfall has been accepted into a pilot program with SCOCA that is worth \$12,000, we do not have to pay for; Mobile devices like Smartphones, iPads, etc. to log in on your class from anywhere; Study Island is being done at the elementary school and the middle school, being used daily; Interactive HD boards, 38 of them in the elementary school classrooms, 9 at the middle school and 5 in the high school; Need about 28 to finish up the district as totally interactive; All the staff is becoming very accustomed to using the technology; Response systems, we have a response system for every single student at the elementary school, high school and middle school only has 3 sets of Senteo response systems; Need to have these for all the students district wide; We have technology that the districts next to us do not have; Students are taking full advantage of technology from first grade on up; Would like to see the middle and high school be able to have same technology advances as the elementary school; Thank you to the Board, Mr. Brady and Ms. Moore for helping us get to the level we are now; It is wonderful to see the students' faces light up when using this technology; Thank you very much for supporting this effort.

Mr. Brady – Mr. Williamson has added a considerable amount of work to his day by helping the district obtain this technology, creating more work for him, yet he always finds time to help when people have questions and has never tried to slow the progress of bringing new technology in for the staff and students; I would like to present him with the "Extra Mile Award" for all he does each day to promote the advancement of technology and education in this district; The Board has asked two different times what more do we need to get the technology in the middle school and high school. Thank you, Mr. Williamson.

2. Westfall Local Schools Presentation – Mr. Jim Brady, Superintendent

One of the problems in passing a levy is explaining why are we spending money if we don't have it; Must get across that all the money being spent on this technology is coming from Federal stimulus money; At the opening day staff meeting we started out with keynote speaker having to cancel, but our own Ms. Theresa Butts gave us a message on how "kindness matters." This topic was reinforced by the WEA and by myself; Ms. Butts showed the video "Who I am Makes A Difference;" I would like to show this to you at this time; When you show students and those around you how much you care, it makes a difference; Gave facts about the report card; Performance index is still continuing to get better; 40% of our population is free/reduced; Despite the cuts we are still an effective district; I would like to bring teachers from more affluent districts here and see if they could be as successful; I don't think they would; But, I guarantee that if our teachers went to a big city school, with all of the needed equipment, information, etc., they would meet all standards; Core Principles of OIP can truly help the students; Parent Reading Workshop, 31 people came; Parents had the opportunity to give feedback. Keep students motivated; Involves routines, goals, feedback, etc.; There must be a change in our approach to teaching; Design clear learning goals; Provide appropriate technology infrastructure; Provide professional development; Prepare student for a whole different world; In an article on April 14, 2010, the Columbus Dispatch was quoted as saying the purchasing of technology equipment with stimulus money is the best way to use the one time infusion of Federal dollars; This equipment will be around for many years to come, while preparing students for the 21st century; Future planning; Continue with interactive white board purchases for the middle and high schools; Teacher peer training and Tech Tuesdays; Student safety(updating security camera, bus cameras and controlling access to the school by visitors); Most money is not coming from general fund, but from permanent improvement and stimulus money; During classroom visits I asked a student what he liked most about school, then I asked what he liked the least and he responded, when he had to go home; Realizing technology has gone mainstream; Even Ohio's largest industry, agribusiness-what we used to call farming-is now dependent on sophisticated satellite connections, computers and mathematics to figure acreage, tillage, fertilizer dispersal rates and a host of other calculations; It is our challenge to ensure education changes to keep up with these changing times.

QUESTIONS FOR THE BOARD

DISCUSSION ITEMS

1. Board Policy Review – Ms. Kristen Earich

Ms. Earich – I had the opportunity to speak to Ms. Greta Gardner at the OSBA conference; The missing pages of the policy revision were left out because there were no changes on them; The document we have is good to go; One of the policies we have been discussing is concerning tobacco use; If we are to vote on the current smoking policy there would be no smoking on district property or in vehicles; We were informed about tobacco being stuffed in areas that should not be, such as sinks, water fountains, etc., which is costly in repairs and in paying manpower to repair; One option we have is to approve no tobacco of any kind on school property; The other option is no tobacco on property by staff members; We have the policy revision to vote on at the end of the meeting; What I'm asking is to decide on what policy to go with concerning tobacco products; Will be a chore to enforce and who enforces; Won't change overnight; What do we want to do as a board?

Ms. Shannon-Policy saying it is okay to use tobacco, but not cigarettes, is sending a mixed message; I know this will be very hard to police.

Mr. Caudill-Would like to exempt the smoking policy for tonight and table for next meeting.

Mr. Carfrey - I would like to table the dress code policy as well for now; I was appalled at the dress of athletes at the fall sports reception.

Ms. Shannon- We will pull these policies out for further consideration.

Ms. Earich — Tobacco use, would the first offence be a verbal reprimmand; Signs would need to be changed; Multiple offences would require removal from property.

Ms. Shannon-Get Ms. Gardner's answer on enforcement.

2. Westfall Athletic Policy – Mr. Jim Brady

Mr. Brady - Mr. Koker is not able to be here because of a prior commitment; The changes on the first paragraph are "in house" recommended changes; This would eliminate some paper work, while still maintaining accurate files; Other changes were recommended from the OHSAA concerning eligibility to participate.

Ms. Shannon- Are these recommendations of the OHSAA?

Ms. Earich – *Is this something we need to do because of OHSAA?*

Mr. Brady – Yes, the other part is in house and would be helpful on record keeping.

Mr. Carfrey - Is this your recommendation?

Mr. Brady- Yes.

ADMINISTRATORS – BUILDING UPDATES

Ms. Payne, Middle School Principal-Thank you to Ms. O'Day and her students; Thank you, Mr. Willliamson for all of your work on the Veteran's Day program; Take a moment to look at web site to see the pictures and video; There have been a number of hits on the web site and relatives from out of state watching the video; Mr. Williamson made DVDs for each veteran to take home and I am very appreciative for all of his help; Mr. Williamson is also doing the Tech Tuesday during collaborative time and the staff loves this training and would like it to stay; Also, he has put some other things on the web site and is training Ms. Nichole Younkin so she can update the middle school section on the site; Last Friday we had an honor roll breakfast and perfect attendance recognition with 99 students having perfect attendance; Thank you, Boosters for the honor roll assemblies; We have five Smartboards installed and the teachers are using them every day; Ms. Hott went to training on flip-cams; Can be connected directly to the Smartboards; Students would like to have the Smartboards in every classroom; The projection screen in the gym is being used for assemblies and we may use them at lunch time to show recorded middle school basketball games, possibly on the web site; Language arts teachers are using Sandbox Creations; Learning about different sites to use and share among themselves; Two teachers are attending advanced Smartboard training and will train other staff members; We had an assembly on bullying for each grade level; We had a parent workshop to train on Study Island; Ms. Putnam and I put together a dance for the students with 250 attending, all of the proceeds will be used for Washington DC trip; We also have a scholarship contest for students not able to afford the trip; The student is asked to write an essay about why he/she should receive the scholarship to go to Washington D.C.; We have \$690 in the fund so far; Friday is the deadline for students to commit to taking the trip; 65 going at this point, will have 80 total; Sub sale is going well, more than 1,000 subs sold at this point; \$4.00 of the \$6.00 charged for the subs goes to the trip; There are order forms in each building; If you buy through the office, the profit will go directly into the scholarship fund; Volunteers are coming to make the subs; Will be made on the November 22nd and out the door on the 23rd; We will make the trip affordable for every student who wants to go this year; Nine students have applied for the scholarship money; If you could read the essays, your heart would be touched; The cost is \$540.00 per student to go; We plan to have another dance, jean day, hat day, etc. for the scholarship fund; The students had to take part in the fundraiser to apply for the scholarship; we need \$2000 to get enough money for all nine scholarship applicants to go.

Ms. Janice Gearhart, Elementary School Principal-The Field of Dreams/WEF have given seed money for service project; Paws for Pets is raising money and collecting leashes for the Pickaway County Humane Society; We have a project to make new students welcome in the building; We are working on connecting with senior citizens in the community to help them with gardening, Meals on Wheels, etc.; Thanks to Mr. Brady, the Board and Mr. Williamson for technology in this school; We have found that our senior staff members are willing to learn new ways of doing things in the classroom; The company has a person who is on call for questions about the Promethean Board and will come and stay in the library to answer any questions; A teacher from each wing will be

going for ITSCO training on flip-cams; Parent Reading Institutes have been established to keep in contact with parents; Nineteen children were in childcare the first night; There is a primary section, intermediate section; Books purchased with Title money; Our staff is doing a wonderful job collaborating on this effort; We are doing it ourselves this year, serving 21 parents this year; Collaboration before school is continuing and teachers are reorganizing their curriculum maps; We have sent a few teachers to team building sessions at the Central Ohio ESC; We were not able to send the whole team, but they are going to meet to help us all learn about team building; Author, Mr. Rick Rieser and his "chickens," came to speak to the children about bullying and appreciating differences; Our music programs are always great; The holiday music program will be Dec. 2nd with a Wild West theme.

Mr. Billy Dennis, High School Assistant Principal and Special Education Coordinator - The music program at the Night of Harmony was excellent; Thank you to Mr. Brady and Mr. Metzger for putting together the Veterans Program; We had a cyberbullying presentation for the students; Many were shocked at what could happen; Olivia Cobb received Honorable Mention All State for volleyball; Thank you to Mr. Williamson for answering all of our technology questions; He is doing a great job in teaching all of us new things about technology; Keep the initiative going with technology; Students want to continue to use the Smartboards; Those who don't have it, want it; The new security cameras are being installed and will cover the building much better; The personnel in the high school office cannot see anyone coming in; Access to building will be more difficult, but will be much safer; Bus cameras are working and we are very happy with them; Helps to eliminate any argument about what may have happened on the bus; Mr. Williamson has assured us that students cannot go on the bus to steal the hard drive, must have special keys, only Ms. Shaw and myself will have keys; Teacher collaboration is still going on and gets more positive as it continues; Every Friday we talk about students and their needs; Primary concern is what we can do to help the students; We are working on identifying kids with reading and comprehension needs to get problems addressed; Will continue to talk to the staff on special education and reading skills; Will be able to follow a student from the beginning of their education here to help correct problems we are seeing by the time the student reaches the high school level; Special Ed Team will be going for OCALI training concerning autism in Columbus. Ms. Earich-Glad to hear there is intervention.
