Saranac Community Schools Board of Education Meeting #4

The regular meeting of the Saranac Community Schools Board of Education was held on Monday, September 9, 2019 in the Conference Room, Saranac Central Office, 225 Pleasant Street, Saranac, MI.

In the absence of President, Sara Doll, Vice-President, David Price called the meeting to order at 7:00 p.m.

Present: Courtnay, Hawkins, Jackson, Price & VanKuiken.

Absent: Doll & Elliott

Logan Gillette led in the Pledge of Allegiance.

**APPROVAL OF MINUTES:** Minutes from regular meeting dated 8/26/19 was approve as presented.

**TREASURER'S REPORT:** The Treasurer's Report for August was approved as presented.

<u>ADDITIONS, DELETIONS & MODIFICATIONS TO THE AGENDA:</u> Superintendent, Jason Smith would like to add Action Item 9.d., Approve Policy 2410 – Prohibition of Referral or Assistance to the agenda.

#### **COMMENTS FROM GUESTS – AGENDA ITEMS:** None

**STUDENT REPORT:** Logan Gillette from Student Council reported they held their first meeting of the school year, and are beginning to plan homecoming activities. They are scheduling blood drives for the year. There focus has been supporting the Lasby family.

<u>ADMINISTRATOR'S UPDATE:</u> JSH Principal, Josh Leader reported their focus has been to the response of the student tragedy. Students have pulled together and have been great mentors to others. It was with great effort from Mrs. Serne and Mr. Smith to pull together the crisis team in response to this. The animal assistance went very well in the building. We are now trying to get some normalcy back in the building. We have received well wishes that have reached out to the district and the Lasby family.

Adam Eisen will be meeting with seniors to make sure they are on schedule with credits and graduating. Construction is going very well, and we have had a great positive response from the students. Teachers are getting ready to start interventions.

Elementary Principal, Mike Catrell reported they started the school year with a positive assembly regarding goals and challenges. They have completed the Acadence Testing and will be checking to see what students might be in need of intervention assistance. We have a Deaf and Hard of Hearing classroom this year through Ionia County ISD. They have received money from the Saranac Education Foundation for alternative seating in the building. They have had great response from this. The first PTSO meeting is September 16th.

**STUDENT REQUEST:** Motion by VanKuiken, supported by Jackson that the Saranac Board of Education go into Closed Session for the purpose of a student request at 7:16 p.m. The board returned to open session at 7:34 p.m. Yes, Votes: Courtnay, Hawkins, Jackson, Price & VanKuiken. Motion Carried.

Motion by Hawkins, supported by VanKuiken that the Saranac Board of Education approve the student request as presented. The board would like to amend the current motion. Motion by Hawkins, supported by Courtnay that the Saranac Board of Education approve the student request, and that the student be placed, on a behavioral and academic contract as presented. Yes, Votes: Courtnay, Hawkins, Jackson, Price & VanKuiken. Motion Carried.

**BILLS PAID:** Motion by Hawkins, supported by Jackson and unanimously approved that the Saranac Board of Education approve the bills paid from General Fund for August/September, in the amount of \$641,803.85, and from the Building & Site Fund for \$850,403.34 as presented.

**HIRE STAFF:** JSH Principal, Josh Leader has a substitute filling in for the open math position, Mr. Russ Chadwick. He is qualified to teach math in grades K-8. Math is one of the areas that is on the critical shortage list for the State of Michigan. Mr. Chadwick has applied for a Full-Year Basic Substitute Permit, and will be fulfilling his obligation to get the secondary certification to teach at the high school level. I would like to recommend him for this position.

Motion by Courtnay, supported by VanKuiken and unanimously approved that the Saranac Board of Education hire Russell Chadwick as JSH Math teacher as presented.

<u>APPROVE POLICY 2410:</u> Superintendent, Jason Smith reported this policy has to be adopted by the board by October 1, 2019 or be subject to a fine. This policy is **Prohibition of Referral or Assistance** which prohibits "officers, agents, or employees of the Board" from referring a student for an abortion or assisting a pupil in obtaining an abortion. In Neola's policy "officers", vendors, and volunteers by "agents" would cover board members.

Motion by VanKuiken, supported by Courtnay and unanimously approved that the Saranac Board of Education waive past practice of two readings, approve and accept Policy 2410 as presented.

**BOARD REQUESTS/REPORTS:** A board member mentioned that Promise tickets are on sale. We have had many CMAC schools reach out to the district offering assistance in the death of our student.

It has been very heartwarming with the response we have received. We received a very nice thank-you from Tucker McPherson regarding the card we sent him with his ongoing health issues.
