II. Additions to and Adoption of the Agenda

Motion to approve the Agenda as presented made by Jason Parks, seconded by Dr. Bruce Labes. **Motion carried 7-0**.

III. New Business

a. Resolution of Wage Payment

Following discussion, Jason Parks moved to adopt the Resolution of the Board Regarding Wage Payments during Emergency School Closings, seconded by Becki Travis. Requirement Resolution as presented and read aloud:

Resolution of the Board Regarding Wage Payments during Emergency School Closings

WHEREAS, the Board is authorized to expend funds of the North Ottawa School District for purposes necessary in the conduct of the public schools as determined by the Board;

WHEREAS, the Board acknowledges that during an emergency closing, most District employees are instructed not to report for work;

WHEREAS, the board finds that a need exists to address wage payments for employees who are idled resulting from an order by the Ottawa County Health Department in conjunction with the Kansas Department of Health & Environment and the Kansas State Department of Education resulting from the COVID-19 Pandemic of 2020:

WHEREAS, the Board determines that employees who are instructed not to report to work may suffer a loss of pay if the District is closed; and

WHEREAS, the Board concludes that continuing wage payments to all regular employees – contractual and noncontractual, salaried and non-salaried – who suffer a loss in pay due to an emergency closing serves the public purpose of maintaining morale, reducing turnover, and ensuring continuity of District staffing when schools reopen;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of Unified School District 239 North Ottawa County authorizes continued wage payments to all regular employees – contractual and non-contractual and salaried and non-salaried – who are instructed not to report to work during an emergency closing.

The authority granted by the resolution to continue wage payments to idled employees is effective for the period of March 16, 2020 through March 27, 2020, unless the Board takes action to authorize payment during a longer duration.

It is further understood that in the event the Kansas State Board of Education requires the above days to be made up after the end of the regular school term, that the pay received by employees during this emergency school closing will serve as advanced payments and that no additional payments are due for pay previously granted.
