### **REGULAR MEETING**

### SUPERINTENDENT REPORT

Dr. Ritchey reported that Deputy Brian Lyons started today as the District's new School Resource Officer.

#### HEARING OF THE PUBLIC

1. Teresa Litton verbalized her concern that issues with Ms. Shaw have not been resolved. She verbalized her support of Ms. Shaw

Mr. Thompson responded that it is a personnel matter and the Board is working through the process as directed by their attorney.

2. Andrew Morris requested more than a three minute time allotment to read emails from MU alumni who currently serve in the military. Mr. Thompson waived the three minute limit.

Andrew read emails from the individuals listed below, supporting Ms. Shaw:

- a. Sgt Austin David Menker, stationed in Pennsylvania
- b. Airman Blake Smith, stationed in El Paso, Texas
- c. Corporal Kaleb Rue, stationed in Georgia

Andrew inquired about the progression of the targeting situation.

Dr. Ritchey answered that two meetings ago, there was a specific situation that was addressed a few days later. After the last meeting, another concern came to light and was addressed. The second situation involved misunderstanding of administration vs staff.

Andrew further asked about teacher concerns of administrators targeting teachers.

Dr. Ritchey responded that there is a vehicle for staff to resolve issues in both negotiated agreements. Outside of that process, staff can gather in small groups to discuss with administrators.

Mr. Thompson responded that if staff members have a problem, they need to follow the established process to get it resolved and follow the chain of command.

Andrew questioned how the staff member should handle the problem if it is with someone above them on the chain of command.

Mr. Thompson responded that the staff member should seek assistance from Dr. Ritchey or one of the Board members.

Dr. Ritchey added that the District has a compliance officer and people need to be willing to solve the problem.

3. Kelly Jones stated there is a need for training for substitute teachers and aides so there is a larger team to handle student behavior issues.

Dr. Ritchey stated he talked to Mr. Larson at the ESC and training will be scheduled either January or February by the Miami County ESC for new substitute teachers.

Mrs. Grube stated she has discussed the need for more training for the aides with the Miami County ESC.

A RESOLUTION DECLARING THAT THE BOARD OF EDUCATION OF THE MILTON-UNION EXEMPTED VILLAGE SCHOOL DISTRICT HAS REVIEWED THE DOCUMENTS AND INFORMATION PREPARED BY THE CHIEF FISCAL OFFICER OF THE MILTON-UNION EXEMPTED VILLAGE SCHOOL DISTRICT FOR SUBMISSION TO THE BUDGET COMMISSION OF MIAMI COUNTY, OHIO IN RELATION TO THE ALTERNATIVE TAX DOCUMENT FORMAT FILING PROVIDED UNDER SECTION

5705.281 OF THE OHIO REVISED CODE AND AUTHORIZED BY SAID COMMISSION FOR THE FISCAL YEAR 2021, AND THAT SAID BODY APPROVES THE SAME.

WHEREAS, Section 5705.281 of the Ohio Revised Code authorizes and empowers a county budget commission, by an affirmative vote of a majority of its members, including an affirmative vote by the auditor of the county, to waive the requirement that a taxing authority of a subdivision or other taxing unit adopt a tax budget, as is provided under Section 5705.28 of the Ohio Revised Code, and require such taxing authority to provide such information as may be required by the commission to perform its duties under Chapter 5705 of the Ohio Revised Code, including dividing the rates of each of the subdivision's or taxing unit's tax levies as provided under Section 5705.04 of the Ohio Revised Code; and

WHEREAS, pursuant to the terms and provisions of Section 5705.281 of the Ohio Revised Code, the Miami County Budget Commission, by an affirmative vote of a majority of its members, including an affirmative vote by the Auditor of Miami County, Ohio, has authorized and permits the taxing authority of a subdivision or other taxing unit within Miami County, Ohio, to refrain from adopting a tax budget, and has designated the information which the said Budget Commission requires of each taxing authority of a subdivision or other taxing unit to permit the Budget Commission to perform its duties under Chapter 5705 of the Ohio Revised Code; and

WHEREAS, it is the desire and intention of the Board of Education, as the taxing authority of Milton-Union Exempted Village School District, to elect to refrain from adopting a tax budget for the fiscal year 2021, and, in the alternative, to submit to the Budget Commission the information and documents which it has indicated will be necessary in the absence of such adoption; and

WHEREAS, previously by its resolution, the Board of Education declared its said desire and intention, and authorized and directed the Chief Fiscal Officer of the Milton-Union Exempted Village School District to prepare and to submit to the Miami County Budget Commission such information and documents as are necessary incident to said process and submission, and to take such other actions as may be reasonably necessary incident thereto; and,

WHEREAS, the members of the Board of Education have examined such information and documents and approve of the same; NOW, THEREFORE, BE IT:

RESOLVED, by the Milton-Union Exempted Village School District, Miami County, Ohio, that:

- 1. The Board of Education of the Milton-Union Exempted Village School District hereby declares that the members of said body have examined the contents of the information and documents which have been prepared by the Chief Fiscal Officer of the Milton-Union Exempted Village School District for submission to the Miami County Budget Commission under the alternative tax document format provided by Section 5705.281 of the Ohio Revised Code for the fiscal year 2021, and the Board of Education of the Milton-Union Exempted Village School District hereby approves the same; and
- 2. The Board of Education of the Milton-Union Exempted Village School District hereby authorizes and directs the Chief Fiscal Officer of Milton-Union Exempted Village School District to submit such information and documents to Miami County Budget Commission, and to take such other actions as may be reasonably necessary incident to said submission; and
- 3. The Board of Education of the Milton-Union Exempted Village School District hereby finds and determines that all deliberations and actions related to the foregoing were effected in open and public session and in full compliance with Section 121.22 of the Ohio Revised Code, and otherwise as is provided by law.

## Resolution Opposing the State of Ohio EdChoice Scholarship (Voucher) Program

WHEREAS, the Ohio legislature has recently made amendments which greatly increase the number and availability of vouchers for students to attend private/parochial schools at public tax expense, and

WHEREAS, such vouchers will be available to numerous families and students who have never attended the Milton-Union Exempted Village School District or any other public schools and for whom state funding has never been provided to Milton-Union or any other public schools, and

WHEREAS, Milton-Union's state funding could be unjustly decreased by the amount of the vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

WHEREAS, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

WHEREAS, private/parochial school students are not subject to the testing standards required of public school students so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public school evaluation standards, and

NOW, THEREFORE, BE IT RESOLVED by the Milton-Union Exempted Village School District Board of Education that this Board reaffirms its commitment to free accessible public schools adequately and equitably funded to guarantee a comparable education for ALL children and therefore opposes any funding programs, vouchers or otherwise, that have the effect of diverting public tax dollars away from public schools.

BE IT FURTHER RESOLVED that the Treasurer is hereby authorized to forward copies of this Resolution to local representatives of the Ohio General Assembly and State Board of Education.

Notwithstanding the foregoing, the Board reserves the right to raise student-athlete eligibility standards as it deems appropriate for the schools and students under its jurisdiction; and

BE IT FURTHER RESOLVED that the schools under this Board's jurisdiction agree to conduct their athletics programs in accordance with the Constitution, Bylaws, Regulations, Business Rules, interpretations and decisions of the OHSAA and cooperate fully and timely with the Executive Director's office of the OHSAA in all matters related to the interscholastic athletic programs of the schools. Furthermore, the schools under this Board's jurisdiction shall be the primary enforcers of the OHSAA Constitution, Bylaws, Regulations, Business Rules and the interpretations and rulings rendered by the Executive Director's Office. The administrative heads of these schools understand that failure to discharge the duty of primary enforcement may result in fines, removal from tournaments, suspensions from membership and/or other such penalties as prescribed in Bylaw 11.
