Mr. Hampton reported that he had received a letter from James White, Assistant State Superintendent, Financial Services, stating that Bishop School qualified to receive monetary awards for highest Annual Performance Index (API) from Oklahoma Academic Achievement Award (AAA) Program. He said that he hoped the awards would be ready by March.

2. State Aid Comparison

Mr. Hampton presented the State Aid Comparison of FY2010 Midyear Allocation to FY2010 Initial Allocation report. He noted that Bishop School experienced a significant increase for the midyear allocation.

3. District Enrollment

Mr. Hampton presented the Bishop School 2009-2010 District Enrollment worksheet. He said emergency transfers may not be renewed in some grade levels to prevent overcrowding.

4. District Property Values

Mr. Hampton presented the Tax Area District Summary Report for Bishop Public School District from the Comanche County Assessor's Office.

5. Utility Comparisons

Mr. Hampton presented comparison worksheets for Public Service Company of Oklahoma (electricity) and Centerpoint Energy (gas). He said the gas utility remained the same as compared to this time last year and the electricity utility is approximately \$8,000 lower this year as compared to this time last year.

6. Re-roofing Project

Mr. Hampton introduced Cary Dehart, CMS Willowbrook Construction Services, and Robert Wright, LWPB Architect & Planners.

Mr. Dehart and Mr. Wright presented options for the re-roofing; metal vs. single ply (TPO, etc.). They explained the costs involved in the different options also depended on city code requirements.

Mr. Dehart discussed options for the HVAC System. He stated that he estimated seventy tons of cooling units on the roof. He said that approximately ninety tons would be required to meet current fresh air requirements.
