ORDER FOR RECOUNT

On April 17, 2020 a recount petition was filed by Douglas Servais, a candidate for the office of School Board Member From At Large for the School District of Bangor at the Spring Election held on April 7, 2020.

The petition requests a recount of all ballots cast for the office of School Board Member At Large (Town of Bangor, Town of Burns, Town of Farmington, Town of Hamilton, Town of Washington, Village of Bangor, Village of Rockland, Town of Leon, Town of Sparta).

The filing officer has reviewed the petition. The petition is sufficient. Any applicable fee has been received and accepted.

Pursuant to Wis. Stat. § 9.01:

IT IS ORDERED THAT:

1. A recount be conducted of all the votes cast for the office of School Board Member From At Large for the School District of Bangor at the Spring Election held on April 7, 2020 in the School District of Bangor (Town of Bangor, Town of Burns, Town of Farmington, Town of Hamilton, Town of Washington, Village of Bangor, Village of Rockland, Town of Leon, Town of Sparta).
2. The boards of canvassers convene at 9 a.m. on Monday, April 20, 2020 at Bangor High/Middle School IMC to begin the recount. The meeting will be immediately adjourned until such time as materials can be secured, and will reconvene at 9 a.m. on Tuesday, April 21, 2020.
3. The recount be completed by the board of canvassers immediately.
4. The clerk transmit a certified canvass report of the result of the recount and a copy of the minutes of the recount proceedings to the Wisconsin Elections Commission immediately after the completion of the recount.
