Child Internet Protection Act (CIPA) Statement

Lightspeed Software protects against access by adults and minors to visual depictions that are obscene, child pornography, or with respect to use of computers with Internet access by minors - harmful to minors. Lightspeed may be disabled for adults engaged in bona fide research or other lawful purposes. Our policy includes monitoring the online activities of minors. Students are being educated about appropriate online behavior, including interacting with other individuals on social networking websites and in chat rooms and cyber bullying awareness and response. Bishop School District's Internet Safety Policy addresses all of CIPA's requirements.
