## II. TERM

The term of District of Innovation Plan is for five years starting on **December 16, 2019** and ending on **December 16, 2024**, unless amended or terminated earlier by the Snook ISD Board of Trustees or the Texas Education Agency in accordance with HB 1842 of the 84th Texas Legislature. The DOI Committee will annually review the implementation of the District of Innovation Plan and recommend to the Snook ISD Board of Trustees any amendments needed.

I. TIMELINE	
<b>April 14</b>	<b>DEIC Petition</b> The Snook ISD District Education Improvement Committee (DEIC) initiates a petition to the Snook ISD Board of Trustees urging for the District of Innovation (DOI) Plan to be amended.
<b>April 20</b>	<b>Public Hearing</b> The Snook ISD Board of Trustees and the public consider the petition for a DOI Plan amendment.
<b>April 20</b>	<b>Committee Appointment</b> The Snook ISD Board of Trustees appoint a district-wide committee to draft an amendment to the DOI Plan.
<b>April 21</b>	<b>Draft DOI Amendment</b> The appointed DOI Committee reviews policies to consider for DOI Plan and drafts an amendment to the DOI Plan according to HB 1842 of the 84th Texas Legislature.
<b>April 22</b>	<b>DEIC Review &amp; Approval</b> DOI Committee members present the proposed amendment to the DOI Plan to the DEIC committee for approval which requires a majority vote.
<b>April 22</b>	<b>Amendment to DOI Plan Posted</b> Snook ISD posts the proposed amendment to the DOI Plan on the Snook ISD website for public comment for a period of at least 30 days.
<b>April 22</b>	<b>TEA Commissioner Notification</b> Snook ISD sends the proposed amendment to DOI Plan to the TEA Commissioner.
<b>May 27</b>	<b>DOI Plan Approval</b> Earliest date the Snook ISD Board of Trustees can approve the proposed amendment of the DOI Plan.
<b>May 27</b>	<b>TEA Commissioner Notification</b> Earliest date the Snook ISD may submit (1) the adopted DOI Plan with amendments and (2) the notification of school board approval to the TEA Commissioner.

## III. UNIFORM GROUP COVERAGE PROGRAM

### Current Policy: TEC § 22.004(i)

*(i) Notwithstanding any other provision of this section, a district participating in the uniform group coverage program established under Chapter 1579, Insurance Code, may not make group health coverage available to its employees under this section after the date on which the program of coverages provided under Chapter 1579, Insurance Code, is implemented.*

### Proposed Local Policy:

(i) Notwithstanding any other provision of this section, a district participating in the uniform group coverage program established under Chapter 1579, Insurance Code, may make additional group health coverage options available to its employees under this section after the date on which the program of coverages provided under Chapter 1579, Insurance Code, is implemented.

### Benefits of Proposed Policy:

- Increased local control of the group health benefits plan to allow the District to be responsive to employee and community needs.
