Dear Marfa ISD Household:

Due to the recent layoffs & furloughs in our community the food service department at Marfa ISD encourages any households experiencing a change in their household to fill out an application for Free and Reduced-Price School Meals. We especially encourage those households who are experiencing changes in their households and who are currently categorized as reduced or full pay to reapply for free and reduced-price school meals. Although your child/children will not be returning to their school campus this school year, any households who apply for free and reduced-price school meals and qualify for free and reduced-price meals this current school year (2019-2020) will continue with that certification at the beginning of the next school year (2020-2021). EX: your household applied for free/reduced-price school meals last August when school began; your household may have qualified for reduced-price meals or may not have qualified at all last August. Due to current changes (either loss of income or additional household members) in your household, your household may now qualify for free/reduced-price meals, but that determination cannot be made until a new application for free/reduced-price meals is filled out and submitted.

*If you submit a new application now and your household goes from reduced to free or from full pay to reduced or free, the new certification stays with your child/children through the beginning of the next school year (2020-2021).

*The new certification will expire prior to October of 2020 or once a new application is received and processed prior to October 2020.

You may submit your application via email at chernandez@marfaisd.com, drop it off at Robinson Cafeteria Monday-Thursday from 9A to 10A with the cafeteria grab n' go team, drop it off with your child's/children school work packet (campus secretaries will forward to food service) or mail it to: Marfa ISD, Attn: food service, PO Box T, Marfa, TX 79843.
