

 - At the time of the hearing, the Governing Board through its appointed representative shall present the budget to persons attending the hearing. Upon request from any person attending the hearing, the budget shall be explained. Any resident or taxpayer may protest the inclusion of any item in the budget. The Board may choose to discuss and take action at this time to remove the protested item from the agenda. If any member of the Board has a conflict of interest defined in A.R.S. § 38-502 to the specific item protested, the member shall not vote on that specific item.
