B. Call for Public Hearing pursuant to A.R.S. § 15-905 on Fiscal Year 2019-2020 District Annual Expenditure Budget.

No public comments.

C. Presentation of the Fiscal Year 2019-2020 Proposed Budget.

Mr. Soto presented the Proposed Budget. He advised that the property tax is not being adopted yet, as it does not happen until August 15, when the County Board of Supervisors approves the tax rate. We are frozen, so property taxes won't go up. If it changes, it may be the secondary tax rate because of the bonds and the interest we have to pay. The proposed budget includes 5% to all certified and teachers, the 3% to administrators, and the \$1.00 per hour for all classified employees. There were a few changes because of the lack of funding on different title monies. The IDEA Grant got cut tremendously, the Preschool PDG Grant went away, and M&O had to absorb those PDG salaries (\$250,000.00). This also represents an increase of over \$1,000.00 to the beginning salary for teachers, making the base pay \$32,000.00. We want to do something every year to move us up on the beginning salary, to make it attractive for teachers. Dr. Gomez asked if the proposed budget includes the purchase of the Core Knowledge curriculum program. Mr. Soto replied no, it was not included but we have other funds we can use to purchase it. We are still working on the procurement process. Mr. Lindemann asked if we are still laboring under current year funding in

the state? Mr. Soto replied yes for general education but not for special education. Mr. Lindemann asked if we are expecting a minimum wage increase in January? Mr. Soto replied it is the \$1.00 increase for classified. This should be the final minimum wage increase (\$12.00) and then the State is saying it will be a cost of living increase. We are expecting about a 2% going forward every year for classified employees, and potentially all employees.
