# **Committee Reports**

<u>Superintendent/HS Principal:</u> Mr. Rudningen reported about the State Superintendent conference that he attended, he and Mitch Lundby attended the SBA Negotiations seminar. Mr. Rudningen is looking into E-rate funding. Impact aid is being applied for since the Zahl Wildlife Refuge is in our district.

<u>Transportation:</u> Update on the fleet was given. Moved by Mitch Lundby seconded by Nicole Wright to advertise for bids old bus #6 with reserving the right to accept or reject bids at the April board meeting. Motion Carried.

<u>Contracts: Issue 2020-2021 as of March 1, 2020:</u> Moved by Rick Foss seconded by Brent Peterson, to approve to issue the 2020-2021 contracts. Motion Carried.

<u>Oil Lease:</u> Border Resources presented an oil bid to the school. Moved by Mitch to amend the November motion that was approved to include the additional acreage of 4.357 seconded by Brent Peterson. Motion Carried.

<u>Evaluation: Superintendent (due at the March meeting):</u> Evaluations were presented and are due back to Carrie Edwards by February 29, 2020

<u>Business Manager:</u> Mr. Rudningen updated the board on the business manager's office that according to century code the board oversees the business manager not the Superintendent.

Administrative: spending allowance, travel schedule, guidelines and expenses: Table until the March meeting.

Staff: travel guidelines and expenses: Tabled until the March meeting.

School Car use: car age, use and mileage were discussed.

<u>Plan to keep public informed on school events:</u> the website will have a soft launch on the 14<sup>th</sup> of February with the full launch taking place on the 25<sup>th</sup> in connection with P/T Conferences.

Credit Card: Monthly Report was presented.

Name change on credit card: Moved by Brent Peterson seconded by Carlyle Norby to change the name of the Mondak Thunder credit card with ASB to Grenora Activities. Motion Carried.

<u>Trap Club:</u> the league was discussed, there is a 2-hour safety programs prior to trap shoot starting.
